1 **AN ACT to amend** 15.91 of the statutes; **relating to:** appointment of student  
2 members of the Board of Regents of the University of Wisconsin System.

***Analysis by the Legislative Reference Bureau***

Under current law, the Board of Regents of the University of Wisconsin System (board) consists of the state superintendent of public instruction, the president or another member of the Technical College System Board, 14 citizen members, and a student member who is at least 18 years old.

This bill changes the board's membership by adding a student member who is at least 24 years old and represents the views of nontraditional students, such as those who are employed or who are parents.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

3 **SECTION 1.** 15.91 of the statutes is amended to read:

4 **15.91 Board of regents of the University of Wisconsin System; creation.**

5 There is created a board of regents of the University of Wisconsin System consisting  
6 of the state superintendent of public instruction, the president, or by his or her  
7 designation another member, of the technical college system board and 14 citizen

**SECTION 2. Nonstatutory provisions.**

14 (1) Notwithstanding section 15.91 of the statutes, as affected by this act, the  
 15 initial term of the student member who is at least 24 years old expires on May 1, 2007.

TO 2005 SENATE BILL 121**

April 8, 2005 – Offered by Senator HARS DORF.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 3: before that line insert:

3 **“SECTION 1g.** 15.07 (1) (cm) of the statutes is amended to read:

4 15.07 (1) (cm) The term of one member of the ethics board shall expire on each  
5 May 1. The terms of 3 members of the development finance board appointed under  
6 s. 15.155 (1) (a) 6. shall expire on May 1 of every even-numbered year and the terms  
7 of the other 3 members appointed under s. 15.155 (1) (a) 6. shall expire on May 1 of  
8 every odd-numbered year. The terms of the 3 members of the land and water  
9 conservation board appointed under s. 15.135 (4) (b) 2. shall expire on January 1.  
10 The term of the member of the land and water conservation board appointed under  
11 s. 15.135 (4) (b) 2m. shall expire on May 1 of an even-numbered year. The terms of  
12 members of the real estate board shall expire on July 1. The terms of the appraiser  
13 members of the real estate appraisers board and the terms of the auctioneer and

1 auction company representative members of the auctioneer board shall expire on  
2 May 1 in an even-numbered year. The term of the student member of the Board of  
3 Regents of the University of Wisconsin System who is at least 24 years old shall  
4 expire on May 1 of every even-numbered year."

5 **2.** Page 1, line 3: substitute "SECTION 1r" for "SECTION 1".

6 **3.** Page 2, line 11: after "terms" insert "; the 2 student members who are  
7 appointed may not be from the same institution; and a student from the University  
8 of Wisconsin-Madison and a student from the University of Wisconsin-Milwaukee  
9 may not serve on the Board of Regents at the same time."

10 **4.** Page 2, line 15: delete "2007" and substitute "2006".
