

#3 Page 5, line 10: after "thereafter" insert ", the private school shall provide the scores of all standardized tests that it administers to the ~~Legislative~~ ~~Audit~~ Bureau. Beginning in 2006 and annually thereafter". *

#3 Page 5, line 14: delete "received ~~from~~ the School Choice Demonstration Project". *from*

#3 Page 5 line, 15: delete "until 2011".

#3 Page 5 line 20: after that line insert:

"3. Each private school shall report the scores on all standardized tests administered to a pupil attending the private school under this section, and a summary of the results of all such tests administered to pupils attending the school under ~~the program~~, to the pupil's parent or guardian."
