2 1. Page 6, line 22: after that line insert:

3 "SECTION 12m. 121.08 (4) (b) of the statutes, as affected by 2005 Wisconsin Act
4 25, is amended to read:

5 121.08 (4) (b) The amount of state aid that the school district operating under
6 ch. 119 is eligible to be paid from the appropriation under s. 20.255 (2) (ac) shall also
7 be reduced by 45% 30 percent of the amounts paid under s. 119.23 (4) and (4m) in the
8 current school year."

9 2. Page 7, line 11: after that line insert:

10 "(2) The treatment of section 121.08 (4) (b) of the statutes first applies to state
11 aid distributed in the 2006-07 school year."
