

1 AN ACT ...; relating to: placement for adoption. ✓

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

2 SECTION 1. 48.38 (4) (br) <sup>x</sup> of the statutes is created to read:

3 48.38 (4) (br) *Title.*

4 SECTION 2. 48.38 (4) (bm) of the statutes is amended to read:

5 ~~48.38 (4) (bm)~~ A statement as to the availability of a safe and appropriate  
6 placement with a fit and willing <sup>sibling</sup> relative of the child and, if a decision is made not  
7 to place the child with an available <sup>sibling</sup> relative, a statement as to why placement with  
8 the <sup>sibling</sup> relative is not safe or appropriate.
