Assumptions Used in Arriving at Fiscal Estimate

AB 478 requires the Barbering and Cosmetology Examining Board to require all licensed cosmetologists, barbers, aestheticians, electrologists, and manicurists to attend a course in recognizing victims of domestic abuse or violence and referring the victims to appropriate agencies for assistance.
