Assumptions Used in Arriving at Fiscal Estimate

This bill creates an individual income tax checkoff for a prostate cancer research program administered by the Department and creates a Prostate Cancer Research Board attached to DHFS.

The bill creates a continuing program revenue appropriation, to be funded by revenue from the income tax checkoff program. The bill requires the Department to award prostate cancer research grants annually to recipients selected by the Board. The amount of the grants will depend upon the amount of revenue received through the income tax checkoff.

The Department would require additional GPR resources to administer this program. In order to administer the grants and staff the Board meetings, the Department would require 1.0 GPR FTE, a program and planning analyst, at a cost of \$63,400 GPR annually (\$60,300 for salary and fringe and \$3,100 for supplies and services). The administrative costs of the Board, including payments for travel, meals and possible overnight accommodations, are estimated at \$5,000 annually. The total cost of administering this program would be \$68,400 GPR annually.
