

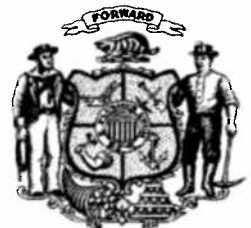

**AB 882: Eligibility for Appointment as a Student Member
of the Board of Regents of the University of Wisconsin System
Testimony by State Representative Joan Ballweg
Before the Assembly Committee on Colleges and Universities
January 10, 2006**

Thank you Chairman Kreibich and fellow committee members for holding this hearing on AB 882, which would clarify the eligibility criteria for appointing a student member to the U.W. Board of Regents. Under current law, the governor may not appoint a student member from the same institution in two consecutive terms. In recent years, two student members of the board of regents started their term as a student of one institution, but completed their term at another U.W. school.

The statute does not address this scenario, so AB 882 would specify that the next student regent could not be appointed from a school that the previous student regent was attending when they applied to be the student regent.

This is a practical need, interested students need to know clearly whether they are or are not eligible to apply. The United Council of UW Students supports this change. I hope that you would support this technical correction to the statute, and I would be happy to answer committee member's questions.
