What we're looking for is that the language in AB 33 not be placed in 74.29, which is regarding settlements. Since the amendment changes the deadline from "August 20th" to "30 days after the county treasurer receives a payment" it makes more sense to have this change made in 74.485 which deals with ag. use conversion penalties. I understand originally with the August deadline placing the language in the settlement statutes made sense, but now that the amendment changes the deadline, I think it would be better placed in the statutes relating to ag. use penalties.

Does that make sense? The whole bill should address the ag. use chapter, not the settlement chapter.

1 AN ACT ...; relating to: the distribution of the penalty for converting agricultural
2 land. ✓

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 74.485[✓] (6) of the statutes is amended to read:

4 74.485 (6) DISTRIBUTION. A county that collects a penalty under this section
5 shall distribute 50% of the amount of the penalty to the taxation district in which the
6 land related to the penalty is located. If the land related to the penalty is located in
7 2 or more taxation districts, the county shall distribute 50% of the amount of the
8 penalty to the taxation districts in proportion to the equalized value of the land
9 related to the penalty that is located in each taxation district. A taxation district
10 shall distribute 50% of any amount it receives under this subsection to an adjoining
11 taxation district, if the taxation district in which the land related to the penalty is
12 located annexed the land related to the penalty from the adjoining taxation district

1 in either of the 2 years preceding a distribution under this subsection. The county
2 shall distribute the amounts provided under this subsection no later than 30 days
3 after receiving a payment under sub. (5).
