*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 SECTION 1. 16.423 (5) of the statutes is created to read:  
4 16.423 (5) Notwithstanding sub. (4), a state agency may use any format for its  
5 report. If a state agency uses a format for a report that is different from the format  
6 that the state agency used for one or more previous reports, the state agency shall  
7 reissue all previous reports in the new format.

8 SECTION 2. 16.43 of the statutes is amended to read:  
9 16.43 Budget compiled. The secretary shall compile and submit to the  
10 governor or the governor-elect and to each person elected to serve in the legislature  
11 during the next biennium, not later than November 20 of each even-numbered year,  
12 a compilation giving all of the data required by s. 16.46 to be included in the state

1 budget report, except the recommendations of the governor and the explanation  
2 thereof. The secretary shall not include in the compilation any provision for the  
3 development or implementation of an information technology development project  
4 for an executive branch agency that is not consistent with the strategic plan of the  
5 agency, as approved under s. 16.976. The secretary may distribute the budget  
6 compilation in printed or optical disk format. As part of the budget compilation, the  
7 secretary shall also submit the most recent base budget review reports under s.  
8 16.423 for each state agency and the most recent statements submitted under s.  
9 16.42 (1) (b) for each state agency.
