

1 AN ACT to repeal 29.569 (2); and to amend 29.569 (1) of the statutes; relating  
2 to: hunting of deer during the open bow hunting season.

*Analysis by the Legislative Reference Bureau*

Current law, with limited exceptions, prohibits a person who is issued a deer hunting license that authorizes hunting deer with a bow and arrow during the open deer bow hunting season from using the license until three days after it is issued. This bill repeals this prohibition.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 SECTION 1. 29.569 (1) of the statutes is amended to read:  
4 29.569 (1) SPECIFICATION OF EFFECTIVE PERIODS; RESTRICTIONS. Unless an  
5 approval issued under this chapter is suspended or revoked or unless another section  
6 of this chapter specifically provides otherwise, the approval is valid for the period or  
7 season specified on the face of the approval or on an attachment to the approval. In  
8 addition to any other restriction under this chapter, no license may be issued if that  
9 issuance is restricted under sub. (2) or (3).
