Natalie and Eric:

The initial draft of your proposal (LRB 3988/P1) amended only s. 79.04 (4m) by comparing the aid on the production plant's current value to its 1990 value. In moving to later drafts, a more comprehensive 1990 hold harmless was adopted that incorporates the value of substations and general structures. This required the creation of a new paragraph -- s. 79.04 (4m) (b). In the editing process, the current bill failed to delete the addition of the word "either", which was a part of LRB 3988/P1 (see page 2, line 12). This word relates entirely to the comparison in the P/1 version of the bill and is superfluous to AB 865. I've asked Joe Kreye to draft a simple amendment to AB 865 deleting "either". Please advise Joe if either or both Representatives Seidel and Petrowski want to be listed as authors. Another option would be to let the Assembly Energy and Utilities Committee offer the amendment. I'm sorry I missed this earlier. Please let me know if you have any questions.
