WILLIAMS, TOWNSEND and HINTZ, cosponsored by Senators ROBSON, RISSER, BRESKE, LEHMAN, OLSEN, MILLER, DARLING, HANSEN, VINEHOUT and LASSA. Referred to Committee on Rules.

1 **Relating to:** appreciating the contributions of free health clinics in Wisconsin.

2 Whereas, free health clinics and federally qualified health centers in Wisconsin
3 have demonstrated importance in their communities; and

4 Whereas, free health clinics and federally qualified health centers are
5 dedicated to the provision of high quality primary health care and health
6 information free or at low cost to the medically underserved residents of their
7 communities; and

8 Whereas, free health clinics and federally qualified health centers provide
9 millions of dollars' worth of services with much smaller operating budgets; and

10 Whereas, free health clinics and federally qualified health centers provide vital
11 health care services to individuals with no health insurance, medicare, medicaid, or
12 medical assistance or with income levels at or below 185 percent of federal poverty
13 guidelines; and

14 Whereas, prescriptions and affordable health care are in demand in
15 communities across Wisconsin; and
