

October 23, 2007 - Offered by COMMITTEE ON FINANCIAL INSTITUTIONS.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 7, line 23: delete "department, the attorney general, or any district
- 3 attorney" and substitute "department or the department of justice, after consulting
- 4 with the department, or any district attorney, upon informing the department,".
- 5 **2.** Page 8, line 11: after that line insert:
- 6 **"SECTION 2m.** 165.25 (4) (ar) of the statutes, as affected by 2005 Wisconsin Act
- 7 458, is amended to read:
- 8 165.25 (4) (ar) The department of justice shall furnish all legal services
- 9 required by the department of agriculture, trade and consumer protection relating
- 10 to the enforcement of ss. 100.171, 100.173, 100.174, 100.175, 100.177, 100.18,
- 11 100.182, 100.20, 100.205, 100.207, 100.209, 100.21, 100.28, 100.37, 100.42, 100.50,

1 100.51, 100.55, and 100.195 and chs. 126, 136, 344, 704, 707, and 779, together with
2 any other services as are necessarily connected to the legal services.”.
