Senator Breske would like to request a simple amendment to SB404. The amendment is actually based off of Representative Schneider's amendment to AB101.

Two parts:
In SB404

1. page 4, line 3: "...company that has hired an illegal alien in violation of 8 US 1324 a (a) shall, for a period of 7 years beginning with..."
2. page 4, line 19: "...number, unless the company corrects addresses the problem described in the notice, in the manner prescribed under federal law, ~~no later than 30 days after receiving the notice.~~"
