Page 25, Line 20 – Begin a new line

(4) REGIONAL NON-PRECEDENCE. Award any project (credit, program, ??) without regard to location of previous projects.

(I think it could be that simple. We just want to say that a project cannot be denied an award based –in any way—upon earlier projects awarded in proximity to the current project under consideration. A region should not be punished for successful economic growth.)

5 2. The department may not deny certification under this section to a person for

7 same political subdivision, provided the requirements of par. (a) are satisfied.”
