

The 2007-09 biennial budget act allocated to the Board of Regents (board) of the University of Wisconsin (UW) System \$664,800 in general purpose revenue in fiscal year 2008-09 for the purpose of doing all of the following at the UW-La Crosse: 1) providing additional financial aid; 2) increasing the number of degrees awarded, student diversity, and academic excellence; and 3) maintaining or improving retention and graduation rates. This bill requires the board to expend the entire amount of the allocation on providing additional financial aid at the UW-La Crosse.
