

**SENATE AMENDMENT 1,  
TO SENATE SUBSTITUTE AMENDMENT 1,  
TO 2007 SENATE BILL 40**

June 26, 2007 – Offered by Senator ROBSON.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 2, line 7: after that line insert:

3 **“SECTION 3.** 7.33 (4) of the statutes is amended to read:

4 7.33 **(4)** Except as otherwise provided in this subsection, each local  
5 governmental unit, as defined in s. 16.97 (7), may, and each state agency shall, upon  
6 proper application under sub. (3), permit each of its employees to serve as an election  
7 official under s. 7.30 without loss of fringe benefits or seniority privileges earned for  
8 scheduled working hours during the period specified in sub. (3), without loss of pay  
9 for scheduled working hours during the period specified in sub. (3) except as provided  
10 in sub. (5), and without any other penalty. For employees who are included in a  
11 collective bargaining unit for which a representative is recognized or certified under

1 subch. V or VI of ch. 111, this subsection shall apply unless otherwise provided in a  
2 collective bargaining agreement.”.

3 **2.** Page 4, line 2: after that line insert:

4 “**SECTION 4d.** 13.101 (6) (a) of the statutes, as affected by 2007 Wisconsin Act  
5 .... (this act), is amended to read:

6 13.101 **(6)** (a) As an emergency measure necessitated by decreased state  
7 revenues and to prevent the necessity for a state tax on general property, the  
8 committee may reduce any appropriation made to any board, commission,  
9 department, or the University of Wisconsin System, or to any other state agency or  
10 activity, by such amount as it deems feasible, not exceeding 25% of the  
11 appropriations, except appropriations made by ss. 20.255 (2) (ac), (bc), (bh), (cg), and  
12 ~~(vf)~~ (cr), 20.395 (1), (2) (cq), (eq) to (ex) and (gq) to (gx), (3), (4) (aq) to (ax), and (6) (af),  
13 (aq), (ar), and (au), 20.435 (6) (a) and (7) (da), and 20.445 (3) (a) and (dz) or for forestry  
14 purposes under s. 20.370 (1), or any other moneys distributed to any county, city,  
15 village, town, or school district. Appropriations of receipts and of a sum sufficient  
16 shall for the purposes of this section be regarded as equivalent to the amounts  
17 expended under such appropriations in the prior fiscal year which ended June 30.  
18 All functions of said state agencies shall be continued in an efficient manner, but  
19 because of the uncertainties of the existing situation no public funds should be  
20 expended or obligations incurred unless there shall be adequate revenues to meet the  
21 expenditures therefor. For such reason the committee may make reductions of such  
22 appropriations as in its judgment will secure sound financial operations of the  
23 administration for said state agencies and at the same time interfere least with their  
24 services and activities.”.

14 Authority, or any local professional baseball park district created under subch. III  
15 of ch. 229 if the construction is undertaken by the department of administration on  
16 behalf of the district, shall be in compliance with all applicable state laws, rules,  
17 codes and regulations but the construction is not subject to the ordinances or  
18 regulations of the municipality in which the construction takes place except zoning,  
19 including without limitation because of enumeration ordinances or regulations  
20 relating to materials used, permits, supervision of construction or installation,  
21 payment of permit fees, or other restrictions.”.

23           “**SECTION 9nd.** 13.48 (36) of the statutes is created to read:

1           **13.48 (36) HMONG CULTURAL CENTER.** (a) The legislature finds and determines  
2 that a significant number of Hmong people are citizens of this state, that the Hmong  
3 people have a proud heritage that needs to be recognized and preserved, and that the  
4 Hmong people have experienced difficulties assimilating in this state. The  
5 legislature finds that supporting the Hmong people in their efforts to recognize their  
6 heritage and to realize the full advantages of citizenship in this state is a statewide  
7 responsibility of statewide dimension. Because it will better ensure that the heritage  
8 of the Hmong people is preserved and will better enable the Hmong people to realize  
9 the full advantages of citizenship in this state, the legislature finds that it will have  
10 a direct and immediate effect on a matter of statewide concern for the state to  
11 facilitate the purchase or construction and operation of a Hmong cultural center.

12           (b) The building commission may authorize up to \$2,000,000 in general fund  
13 supported borrowing to make a grant to an organization designated by the secretary  
14 of administration that represents the cultural interests of Hmong people for  
15 purchase or construction of a Hmong cultural center in Dane County. Before  
16 approving any state funding commitment for the purchase or construction of the  
17 center and before awarding the grant, the building commission shall determine that  
18 the organization has secured additional funding commitments of at least \$2,500,000  
19 from nonstate revenue sources for purchase or construction of the center. Before  
20 awarding the grant, the organization shall submit to the building commission and  
21 the commission shall review and approve an initial budget and business plan for the  
22 operation of the center that is acceptable to the commission. As a condition of  
23 receiving the grant, the organization must enter into an agreement with the  
24 secretary guaranteeing that the center will be operated to serve the nonsectarian  
25 cultural interests of the Hmong people.

1 (c) If, for any reason, the facility that is purchased or constructed with funds  
2 from the grant under par. (b) is not used as a Hmong cultural center in Dane County,  
3 or the center is not operated to serve the nonsectarian cultural interests of the  
4 Hmong people, the state shall retain an ownership interest in the facility equal to the  
5 amount of the state's grant.”.

9 legislature finds and determines that the Civil War was an event of unequaled  
10 importance in the historical development of the United States; that Wisconsin  
11 citizens fought bravely and valiantly in assisting the Union to achieve victory in the  
12 Civil War; and that the study of the Civil War will deepen our understanding and  
13 appreciation of the history of the United States and of Wisconsin. It is therefore in  
14 the public interest, and it is the public policy of this state, to assist the Kenosha  
15 Public Museums in the construction of facilities that will be used for a Civil War  
16 exhibit.

17 (b) The building commission may authorize up to \$500,000 in general fund  
18 supported borrowing to aid in the construction of a Civil War exhibit as part of the  
19 Kenosha Public Museums in the city of Kenosha. The state funding commitment  
20 shall be in the form of a grant to the Kenosha Public Museums. Before approving any  
21 such state funding commitment and before awarding the construction grant, the  
22 building commission shall determine that the Kenosha Public Museums has secured  
23 additional funding at least equal to \$2,000,000 from nonstate donations for the  
24 purpose of constructing a Civil War exhibit.

1 (c) If the building commission authorizes a grant to the Kenosha Public  
2 Museums under par. (b) and if, for any reason, the facility that is constructed with  
3 funds from the grant is not used as a Civil War exhibit, the state shall retain an  
4 ownership interest in the facility equal to the amount of the state's grant.”.

11 Oconto plays a vital role in improving the health of the citizens of this state and is  
12 a quality health care facility. The legislature, therefore, finds and determines that  
13 assisting the Bond Health Center in the city of Oconto in expanding a health care  
14 facility will have a direct and immediate effect on this state responsibility of  
15 statewide dimension.

16 (b) The building commission may authorize up to \$1,000,000 in general fund  
17 supported borrowing to make a grant to the Bond Health Center in the city of Oconto  
18 for construction costs related to hospital expansion. Before approving any state  
19 funding commitment for construction costs relating to the hospital expansion and  
20 before awarding the grant, the building commission shall determine that the Bond  
21 Health Center has secured all necessary additional funding commitments from  
22 nonstate revenue sources for the expansion.

1 (c) If, for any reason, the facility that is expanded with funds from the grant  
2 under par. (b) is not used as a hospital, the state shall retain an ownership interest  
3 in the facility equal to the amount of the state's grant.”.

19 the organization for economic cooperation and development as a tax haven or as  
20 having a harmful, preferential tax regime or has no, or a nominal, effective tax on  
21 income and all of the following apply:

22           1. The jurisdiction has laws or practices that prevent the effective exchange of  
23 information, for tax purposes, with other governments on taxpayers benefiting from  
24 the tax regime.

1           2. The details of the legislative, legal, or administrative provisions of the  
2 jurisdiction's tax regime are not publicly available and apparent or are not  
3 consistently applied to similarly situated taxpayers or the information needed by tax  
4 authorities to determine a taxpayer's correct tax liability, including accounting  
5 records and underlying documentation, is not adequately available.

6           3. The jurisdiction facilitates the establishment of foreign-owned entities  
7 without requiring a local substantive presence or prohibits such entities from having  
8 any commercial impact on the local economy.

9           4. The tax regime explicitly or implicitly excludes the jurisdiction's resident  
10 taxpayers from taking advantage of the tax regime's benefits or prohibits enterprises  
11 that benefit from the regime from operating in the jurisdiction's domestic market.

12           5. The jurisdiction has created a tax regime that is favorable for tax avoidance,  
13 based upon an overall assessment of relevant factors, including whether the  
14 jurisdiction has a significant untaxed offshore financial or other services sector  
15 relative to its overall economy.

16           (i) "Taxpayer member" means a corporation that is subject to tax under s. 71.23  
17 (1) or (2) and that is a member of a combined group.

18           (j) "Unitary business" means a single economic enterprise that consists of  
19 separate parts of a single business entity or of a commonly controlled group of  
20 business entities that are sufficiently interdependent, integrated, and interrelated  
21 by their activities so as to provide a synergy and a mutual benefit that produces a  
22 sharing or exchange of value among them and a significant flow of value to the  
23 separate parts. For purposes of this section, 2 or more business entities are  
24 considered a unitary business if the entities have unity of ownership, operation, and  
25 use, as indicated by centralized management or a centralized executive force;

1 centralized purchasing, advertising, or accounting; intercorporate sales or leases;  
2 intercorporate services; intercorporate debts; intercorporate use of proprietary  
3 materials; interlocking directorates; or interlocking corporate officers. Any business  
4 conducted by a pass-through entity that is owned directly or indirectly by a  
5 corporation is considered conducted by the corporation, to the extent of the  
6 corporation's distributive share of the pass-through entity's income, regardless of  
7 the percentage of the corporation's ownership interest. A business conducted  
8 directly or indirectly by one corporation is unitary with that portion of a business  
9 conducted by another corporation through its direct or indirect interest in a  
10 pass-through entity, if the corporations are sufficiently interdependent, integrated,  
11 and interrelated by their activities so as to provide a synergy and a mutual benefit  
12 that produces a sharing or exchange of value among them and a significant flow of  
13 value to the separate parts and the two corporations are members of the same  
14 commonly controlled group.

15 **(2) CORPORATIONS REQUIRED TO USE COMBINED REPORTING.** (a) A corporation  
16 engaged in a unitary business with any other corporation shall file a combined report  
17 that includes the income, determined under sub. (3), and apportionment factor,  
18 determined under sub. (5) and s. 71.25, of the following members of the unitary  
19 business:

20 1. Any member incorporated in the United States, including the District of  
21 Columbia and any territory or possession of the United States, or formed under the  
22 laws of any state, the District of Columbia, or any territory or possession of the  
23 United States.

24 2. Any member, regardless of where the entity is incorporated or formed, if the  
25 average of the following ratios is 20 percent or more:

1           a. The value of the member's real property and tangible personal property  
2 located in the United States, including the District of Columbia and any territory or  
3 possession of the United States, not including property that is used to produce  
4 nonapportionable income, divided by the value of all of the member's real property  
5 and tangible personal property, not including property that is used to produce  
6 nonapportionable income. For purposes of this subd. 2. a., the value of property that  
7 the member rents is the net annual rental amount for the property, multiplied by 8.

8           b. The amount of the member's payroll that is paid in the United States,  
9 including the District of Columbia and any territory or possession of the United  
10 States, divided by the amount of the member's total payroll. For purposes of this  
11 subd. 2. b., payroll includes compensation paid to employees, but does not include  
12 payroll used to produce nonapportionable income. The payroll paid in the United  
13 States, including the District of Columbia and any territory or possession of the  
14 United States, shall be determined in the same manner as payroll is determined for  
15 this state under s. 71.25 (8) (b) 1. to 5.

16           c. The member's sales in the United States, including the District of Columbia  
17 and any territory or possession of the United States, divided by the member's total  
18 sales. For purposes of this subd. 2. c., sales include items identified in s. 71.25 (9) (e),  
19 but not items identified in s. 71.25 (9) (f), and the situs of a sale shall be determined  
20 in the same manner as for state sales in s. 71.25 (9) (b), (d), (df), and (dh), not  
21 including s. 71.25 (9) (b) 2m. and 3., (c), (df) 3., and (dh) 4.

22           3. Any member that is a domestic international sales corporation as described  
23 in sections 991 to 994 of the Internal Revenue Code, a foreign sales corporation as  
24 described in sections 921 to 927 of the Internal Revenue Code, or an export trade  
25 corporation as described in sections 970 to 971 of the Internal Revenue Code.

1           4. Any member that is a controlled foreign corporation as defined in section 957  
2 of the Internal Revenue Code, to the extent of the member's income that is defined  
3 in section 952 of of the Internal Revenue Code, including any lower-tier subsidiary's  
4 distribution of such income that was previously taxed, determined without regard  
5 to federal treaties, and the apportionment factors related to that income. For  
6 purposes of this subdivision, any item of income received by a controlled foreign  
7 corporation is excluded if the income was subject to an income tax imposed by a  
8 foreign country at an effective tax rate greater than 90 percent of the maximum tax  
9 rate specified in section 11 of the Internal Revenue Code.

10           5. Any member that earns more than 20 percent of its income, directly or  
11 indirectly, from intangible property or service-related activities that are deductible  
12 against the business income of other members of the combined group, to the extent  
13 of that income and the apportionment factors related to that income.

14           6. Any member that is doing business in a tax haven, if the member is engaged  
15 in an activity that is sufficient for that tax haven jurisdiction to impose a tax under  
16 federal law. If the member's business activity in a tax haven is entirely outside the  
17 scope of the laws and practices that cause the jurisdiction to be a tax haven, the  
18 member's business activity is not considered to be conducted in a tax haven for  
19 purposes of this section.

20           7. Any member not described in subds. 1. to 6., to the extent that its income is  
21 derived from or attributable to sources within the United States, including the  
22 District of Columbia and any territory or possession of the United States, as  
23 determined under the Internal Revenue Code and by its apportionment factors  
24 related to that income.

1           (b) The department may require that a combined report filed under this section  
2 include the income and associated apportionment factors of any persons not  
3 described under par. (a) that are members of a unitary business to reflect the proper  
4 apportionment of income of the entire unitary business, including persons that are  
5 not, or would not be, subject to the taxes imposed under this chapter if doing business  
6 in this state.

7           **(3) COMPONENTS OF INCOME SUBJECT TO TAX.** Each taxpayer member is  
8 responsible for the tax imposed under this chapter based on its taxable income or loss  
9 apportioned or allocated to this state, including:

10           (a) Its share of any business income apportionable to this state of each of the  
11 combined groups of which it is a member, as determined under subs. (4) and (5).

12           (b) Its share of any business income apportionable to this state of a distinct  
13 business activity conducted in and outside this state wholly by the taxpayer member,  
14 as determined under s. 71.25.

15           (c) Its income from a business conducted wholly by the taxpayer member  
16 entirely in this state.

17           (d) Its income sourced to this state from the sale or exchange of capital or assets  
18 and from involuntary conversions, as determined under sub. (4) (a) 8.

19           (e) Its nonbusiness income or loss allocable to this state.

20           (f) Its income or loss allocated or apportioned in an earlier year that is state  
21 source income during the income year, other than a net business loss carry-forward.

22           (g) Its net business loss carry-forward. If the taxable income computed under  
23 this subsection and subs. (4) and (5) results in a loss for a taxpayer member of the  
24 combined group, the taxpayer member has a net business loss, subject to the net  
25 business loss limitations and carry-forward provisions in s. 71.26 (4). The business



1 loss is applied as a deduction in a subsequent year only if the taxpayer member has  
2 net income sourced to this state, regardless of whether the taxpayer is a member of  
3 a combined group in the subsequent year.

4 **(4) BUSINESS INCOME OF THE COMBINED GROUP.** The business income of a  
5 combined group is determined as follows:

6 (a) Compute the sum of the income of each member of the combined group as  
7 determined for federal income tax purposes, as if the members were not consolidated  
8 for federal purposes, and modified as provided under s. 71.26. Each member of the  
9 combined group shall determine its income as follows:

10 1. For any member incorporated in the United States, including the District of  
11 Columbia and any territory or possession of the United States, or included in a  
12 consolidated federal corporate income tax return, the income included in the total  
13 income of the combined group is the corporation's taxable income as determined  
14 under s. 71.26.

15 2. Except as provided in subd. 3, for any member not included in subd. 1., the  
16 income included in the total income of the combined group shall be determined as  
17 follows:

18 a. Each foreign branch or foreign corporation shall prepare a profit and loss  
19 statement in the currency in which the branch's or corporation's books of account are  
20 regularly maintained.

21 b. The member shall adjust any statement prepared under subd. 2. a. to  
22 conform to the accounting principles generally accepted in the United States for the  
23 preparation of profit and loss statements.

1           c. The member shall adjust any statement prepared under subd. 2. a. to  
2 conform to the tax accounting standards required by the department for the  
3 administration of this chapter.

4           d. Each member of the combined group shall translate its profit and loss  
5 statements, and the related apportionment factors, into the currency in which the  
6 parent corporation maintains its books and records.

7           e. Each member shall express in U.S. dollars the income apportioned to this  
8 state.

9           3. If the department determines that the income determination under this  
10 subsection reasonably approximates income as determined under s. 71.26, any  
11 member not included in subd. 1. may determine its income based on a consolidated  
12 profit and loss statement that includes the member and that is prepared for the  
13 purpose of filing, by related corporations, with the securities and exchange  
14 commission. If the member is not required to file with the securities and exchange  
15 commission, the department may allow, for purposes of this subdivision, the use of  
16 the consolidated profit and loss statement prepared for reporting to shareholders  
17 and subject to review by an independent auditor. If a statement described in this  
18 subdivision does not reasonably approximate income as determined under s. 71.26,  
19 the department may accept the statement if the member makes appropriate  
20 adjustments to the statement, as determined by the department, to approximate the  
21 income determined under s. 71.26.

22           4. If a unitary business includes income from a pass-through entity, the total  
23 income of the combined group includes the member's direct and indirect distributive  
24 share of the pass-through entity's unitary business income.

1           5. All dividends paid by one member to another are not included in the  
2 recipients income, if the dividends are paid out of the earnings and profits of the  
3 unitary business in the current taxable year or in an earlier taxable year. This  
4 subdivision does not apply to dividends received from members of a unitary business  
5 that are not a part of the combined group.

6           6. Except as provided by the department by rule, business income or loss from  
7 an intercompany transaction between members of the same combined group shall be  
8 deferred in a manner similar to 26 CFR 1.1502–13. Upon the occurrence of any of  
9 the following events, deferred business income or loss resulting from an  
10 intercompany transaction between members of a combined group shall be included  
11 in the income of the seller and shall be apportioned as business income earned  
12 immediately before the event:

13           a. The object of the deferred intercompany transaction is sold by the buyer to  
14 an entity that is not a member of the combined group.

15           b. The object of the deferred intercompany transaction is sold by the buyer to  
16 an entity that is a member of the combined group for use outside the unitary business  
17 in which the buyer and seller are engaged.

18           c. The object of the deferred intercompany transaction is converted by the buyer  
19 to a use outside the unitary business in which the buyer and seller are engaged.

20           d. The buyer and seller are no longer members of the same combined group,  
21 regardless of whether the members remain a unitary business.

22           7. A charitable expense incurred by a member of a combined group, to the  
23 extent allowable as a deduction under section 170 of the Internal Revenue Code,  
24 shall be subtracted first from the business income of the combined group, subject to  
25 the income limitations of section 170 of the Internal Revenue Code as it applies to

1 the entire business income of the group, and any remaining amount shall be treated  
2 as a nonbusiness expense allocable to the member that incurred the expense, subject  
3 to the income limitations of section 170 of the Internal Revenue Code as it applies  
4 to the nonbusiness income of that member. Any charitable deduction described  
5 under this subdivision that is allowed as a carryover deduction in a subsequent year  
6 is considered to be originally incurred in the subsequent year by the same member,  
7 and this section applies in the subsequent year for purposes of determining the  
8 allowable deduction in that year.

9 8. Gain or loss from the sale or exchange of capital assets, property described  
10 in section 1231 (a) (3) of the Internal Revenue Code, and property subject to an  
11 involuntary conversion, is removed from the total separate net income of each  
12 member of a combined group and is apportioned and allocated as follows:

13 a. For short-term capital gains or losses, long-term capital gains or losses,  
14 gains or losses under section 1231 of the Internal Revenue Code, and involuntary  
15 conversions, the business gain and loss of all members are combined within each  
16 class of net business gain or loss and each such class is separately apportioned to each  
17 member using the member's apportionment percentage determined under sub. (5).

18 b. Each taxpayer member shall net its apportioned business gain or loss for all  
19 classes, as determined under subd. 8. a., including any such apportioned business  
20 gain and loss from other combined groups, against the taxpayer member's  
21 nonbusiness gain and loss for all classes allocated to this state as provided under  
22 sections 1231 and 1222 of the Internal Revenue Code, not including nonbusiness  
23 items allocated to another state.

24 c. Any resulting state source income or loss, if the loss is not subject to section  
25 1211 of the Internal Revenue Code, of a taxpayer member produced by the

1 application of subd. 8. a. and b. shall then be applied to all other state source income  
2 or loss of that member.

3 d. Any resulting state source loss of a member that is subject to section 1211  
4 of the Internal Revenue Code shall be carried forward or carried back by that  
5 member and shall be treated as state source short-term capital loss incurred by that  
6 member for the year for which the carry-forward or carry-back applies.

7 9. Any expense of one member of the unitary business that is directly or  
8 indirectly attributable to the nonbusiness or exempt income of another member of  
9 the unitary business shall be allocated to that other member as corresponding  
10 nonbusiness or exempt expense, as appropriate.

11 (b) Subtract any nonbusiness income of the combined group from the amount  
12 determined under par. (a) and add any nonbusiness expense or loss of the combined  
13 group to the amount determined under par. (a).

14 **(5) TAXPAYER'S SHARE OF BUSINESS INCOME OF A COMBINED GROUP.** The taxpayer's  
15 share of the business income apportionable to this state of each combined group of  
16 which it is a member shall be the product of the business income of the combined  
17 group as determined under sub. (4) and the taxpayer member's sales factor  
18 percentage, determined under s. 71.25, modified as follows:

19 (a) Include in the numerator the taxpayer member's sales associated with the  
20 combined group's unitary business in this state.

21 (b) Include in the numerator the taxpayer member's sales associated with the  
22 combined group's unitary business to another state in which the taxpayer member  
23 is not engaged in business, regardless of whether another member of the combined  
24 group is engaged in business in the other state.

1 (c) Include in the denominator the sales of all members of the combined group,  
2 including the taxpayer, that are associated with the combined group's unitary  
3 business regardless of where that business is located.

4 (d) Include sales of a pass-through entity owned directly or indirectly by a  
5 corporation in proportion to a ratio the numerator of which is the amount of the  
6 corporation's distributive share of the pass-through entity's unitary income included  
7 in the income of the combined group in under sub. (4) and the denominator of which  
8 is the amount of the pass-through entity's total unitary income.

9 (e) Exclude sales between members of the combined group.

10 (f) If a member of a combined group is not subject to the taxes imposed under  
11 s. 71.23 because it is not engaged in business in this state, the numerator of the  
12 member's sales factor is zero.

13 **(6) CREDITS AND POST-APPORTIONMENT DEDUCTIONS.** No tax credit or  
14 post-apportionment deduction earned by one member of the combined group, but not  
15 completed, used by, or allowed to that member, may be used in whole or in part by  
16 another member of the combined group or applied in whole or in part against the total  
17 income of the combined group.

18 **(7) DESIGNATED AGENT.** (a) For purposes of administering this section, each  
19 combined group shall appoint a sole designated agent. The designated agent is the  
20 parent corporation of the combined group, if the parent corporation is a taxpayer  
21 member of the combined group and the income of the parent corporation is included  
22 in the combined report. If there is no such parent corporation, the designated agent  
23 may be appointed by the taxpayer members. If there is no such parent corporation  
24 and no taxpayer member is appointed, the designated agent is the taxpayer member  
25 that has the most significant operations in this state on a recurring basis, as

1 determined by the department. The designated agent may change only when the  
2 designated agent is no longer subject to the tax imposed under s. 71.23 (1) or (2), in  
3 which case the combined group shall notify the department of such a change in the  
4 manner prescribed by the department.

5 (b) The designated agent is responsible for acting on behalf of the taxpayer  
6 members of the combined group and shall do all of the following:

7 1. File with the department a combined report under sub. (1) (b).

8 2. File any extensions under s. 71.24.

9 3. File any amended combined reports and claims for refund or credit.

10 4. Send and receive all correspondence with the department regarding the  
11 combined report.

12 5. Remit all taxes, including estimated taxes, to the department. For purposes  
13 of computing interest on late payments, all payments remitted are considered to be  
14 made on a proportionate basis by all taxpayer members of the combined group,  
15 unless otherwise specified by the designated agent.

16 6. Participate on behalf of the combined group members in any investigation  
17 or hearing requested by the department regarding a combined report, produce all  
18 information requested by the department regarding the combined report, and file  
19 any appeal related to a combined report. Any appeal filed by the designated agent  
20 is considered filed by all members of the combined group.

21 7. Execute any waiver, closing agreement, power of attorney, or other document  
22 regarding the combined report filed under sub. (1) (b). Any waiver, agreement, or  
23 document executed by the designated agent is considered executed by all members  
24 of the combined group.

1           8. Receive notices regarding the combined report. Any such notice the  
2 department sends to the designated agent is considered sent to all taxpayer members  
3 of the combined group.

4           9. Receive refunds regarding the combined report. Any such refund shall be  
5 paid to and in the name of the designated agent and shall discharge any liability of  
6 the state to any member of the combined group regarding the refund.

7           (c) The department may relieve the designated agent from any of the duties  
8 described in par. (b) to the extent that the duties relate to income, expense, or loss  
9 that is not includable in the business income of the combined group under sub. (4).  
10 Unless the department provides for such relief by rule, a designated agent shall  
11 obtain written approval from the department to be relieved of any such duties.

12           **(8) TAXABLE YEAR OF THE COMBINED GROUP.** (a) Except as provided in par. (b), the  
13 combined group's taxable year is the designated agent's taxable year. If a member's  
14 taxable year is different from the combined group's taxable year, the designated  
15 agent may elect to determine the portion of each member's income to be included in  
16 the combined report either from a separate income statement from each member that  
17 is prepared by the member's books and records for the months that are included in  
18 the combined group's taxable year or by including in the combined report all of the  
19 income of each member for the year that ends during the combined group's taxable  
20 year. Any election made under this paragraph remains in effect for subsequent years  
21 unless the designated agent submits a request to the department to change the  
22 election and the department approves in writing.

23           (b) If 2 or more members of a combined group file a federal consolidated return,  
24 the combined group's taxable year is the taxable year that corresponds to the federal  
25 consolidated return.



1           **(9) PART-YEAR MEMBERS OF A COMBINED GROUP.** If a corporation becomes a  
2 member of a combined group, or ceases to be a member of a combined group, after  
3 the beginning of the combined group’s taxable year, the corporation’s income shall  
4 be determined as provided under subs. (3), (4), and (5) for that portion of the year in  
5 which the corporation was a member of the combined group, and the income shall be  
6 included in the combined report. The income for the remaining short period shall be  
7 reported on a separate return or separate combined report.

8           **(10) PRESUMPTIONS AND BURDEN OF PROOF.** A commonly controlled group is  
9 presumed to be engaged in a unitary business and all of the income of the unitary  
10 business is presumed to be apportionable business income under this section. A  
11 corporation has the burden of proving that it is not a member of a combined group  
12 that is subject to this section.”.

5 or (b), 125.09 (2), 961.41 (1) or (1m), 961.573, 961.574, or 961.575 or of a substantially  
6 similar federal law or law of another state, if the violation was committed in  
7 connection with or incident to any traveling sales crew activities.

8 2. A violation of s. 940.01, 940.02, 940.03, 940.05, 940.06, 940.07, 940.08.  
9 940.09, 940.10, 940.19 (2), (4), (5), or (6), 940.21, 940.225 (1), (2), or (3), 940.23,  
10 940.24, 940.25, 940.30, 940.305, 940.31, 943.02, 943.03, 943.04, 943.10, 943.30,  
11 943.31, 943.32, 944.32, 944.33 (2), 944.34, 946.10, 948.02 (1) or (2), 948.025, 948.03  
12 (2) or (3), 948.04, 948.05, 948.055, 948.06, 948.07, 948.075, 948.08, 948.085, 948.11  
13 (2) (a) or (am), 948.12, 948.13, 948.21 (1), or 948.30 or of a substantially similar  
14 federal law or law of another state.

15 3. A violation of s. 943.20, 943.201, 943.203, 943.21, 943.23, 943.24 (2), 943.34,

22 salespersons or in related support work, who travel together in a group, and who are  
23 absent overnight from their permanent places of residence for the purpose of selling  
24 goods or services to consumers from house to house, on any street, or in any other  
25 place that is open to the public. “Traveling sales crew” does not include 2 or more

1 individuals who are traveling together for the purpose of participating in a trade  
2 show or convention or 2 or more immediate family members who are traveling  
3 together for the purpose of selling goods or services.

4 (e) “Traveling sales crew activities” means the sale of goods or services to  
5 consumers from house to house, on any street, or in any other place that is open to  
6 the public or related support work.

7 (f) “Traveling sales crew worker” means a member of a traveling sales crew.

8 **(2) REGISTRATION REQUIRED.** No person may employ, offer to employ, or  
9 otherwise recruit an individual to work as a traveling sales crew worker without first  
10 obtaining a certificate of registration from the department. To obtain a certificate  
11 of registration, a person shall complete an application under sub. (3) (a), meet the  
12 minimum requirements specified in sub. (3) (c) for issuance of a certificate of  
13 registration, and pay a registration fee determined by the department by rule  
14 promulgated under sub. (13). A certificate of registration is valid for 12 months  
15 unless sooner suspended, restricted, or revoked and is nontransferable. A registrant  
16 may renew a certificate of registration by submitting an application under sub. (3)  
17 (a) and paying the registration fee not less than 30 days before the expiration date  
18 of the certificate of registration.

19 **(3) APPLICATION FOR REGISTRATION.** (a) To obtain a certificate of registration, a  
20 person shall complete an application that contains all of the following information:

21 1. The name of the applicant, the address and telephone number of the  
22 applicant’s principal place of business and, if the applicant is engaged in sales  
23 activities on behalf of a principal, the name, address, and telephone number of the  
24 principal.

1           2. If the applicant is a corporation, the date and place of the applicant's  
2 incorporation or, if the applicant is a limited liability company, the date and place of  
3 the applicant's organization.

4           3. The names and permanent home addresses of the proprietors, managing  
5 partners, managers, or principal officers of the applicant, together with proof of  
6 identification of those individuals, which may be in the form of a birth certificate, a  
7 valid operator's license issued under ch. 343 or under a comparable law of another  
8 state that contains a photograph of the license holder, or an identification card issued  
9 under s. 343.50 or under a comparable law of another state that contains a  
10 photograph of the person identified.

11           4. The names, permanent home addresses, motor vehicle operator's license  
12 numbers, and dates of birth of all employees, agents, or representatives of the  
13 applicant who supervise or transport traveling sales crew workers, together with  
14 proof of identification of those individuals, as provided under subd. 3.

15           5. Information regarding the conviction record of all proprietors, managing  
16 partners, managers, or principal officers of the applicant, and of all employees,  
17 agents, or representatives of the applicant who supervise or transport traveling sales  
18 crew workers, and information regarding any violation by any of those individuals  
19 of s. 100.18, 100.195, or 100.20, of a rule promulgate under any of those sections or  
20 of a substantially similar federal law or law of another state.

21           6. The social security number or federal employer identification number of the  
22 applicant as provided in sub. (10) (a).

23           7. The type of sales activities to be performed and the nature of the goods or  
24 services to be sold by the traveling sales crew workers of the applicant. If the goods

1 to be sold are magazine subscriptions, the applicant shall provide the names,  
2 addresses, and telephone numbers of the publishers of those magazines.

3 8. A statement identifying each motor vehicle that will be used to transport the  
4 applicant's traveling sales crew workers, including the type and license number of  
5 each motor vehicle, and documentation showing that each motor vehicle is in  
6 compliance with all state and federal safety standards that are applicable to the  
7 motor vehicle as provided in sub. (7) (a).

8 9. A statement indicating whether the duties of the applicant's traveling sales  
9 crew workers will include the storage, handling, or transportation of hazardous  
10 materials or may result in any other exposure of those workers to hazardous  
11 materials and, if so, documentation showing that the applicant is in compliance with  
12 all state and federal safety standards that are applicable to the storage, handling,  
13 and transportation of the hazardous materials as provided in sub. (7) (b).

14 10. Any document required by the department to prove that the applicant has  
15 complied with the proof of financial responsibility requirement under sub. (4), the  
16 disclosure statement requirement under sub. (5), and the proof of insurance  
17 requirement under sub. (8).

18 11. Any other information that the department considers relevant to the  
19 protection of the health, safety, and welfare of the traveling sales crew workers  
20 employed by the applicant.

21 (b) 1. On receipt of an application under par. (a) and payment of the registration  
22 fee under sub. (2), the department of workforce development shall investigate the  
23 applicant to determine whether the applicant is qualified under par. (c) to receive a  
24 certificate of registration. That investigation shall include a criminal history search  
25 by the department of justice of all proprietors, managing partners, managers, or

1 principal officers of the applicant, and of all employees, agents, or representatives  
2 of the applicant who supervise or transport traveling sales crew workers. That  
3 investigation shall also include a search by the department of workforce  
4 development to determine whether any of those individuals has committed a  
5 violation of s. 100.18, 100.195, or 100.20, of a rule promulgated under any of those  
6 sections, or of a substantially similar federal law or law of another state.

7 2. If the person being investigated is, or at any time within the 5 years  
8 preceding the date of the application has been, a nonresident or if the department  
9 of workforce development determines that any information obtained as a result of  
10 the investigation under subd. 1. provides a reasonable basis for further  
11 investigation, the department of workforce development may require the person  
12 being investigated to be fingerprinted on 2 fingerprint cards, each bearing a complete  
13 set of the person's fingerprints. The department of justice may provide for the  
14 submission of the fingerprint cards to the federal bureau of investigation for the  
15 purposes of verifying the identification of the person and obtaining the person's  
16 criminal conviction record. The department of workforce development shall keep  
17 confidential all information received from the department of justice and the federal  
18 bureau of investigation under this subdivision.

19 (c) Subject to par. (d) and sub. (10) (b) and (c), after completing the investigation  
20 under par. (b), the department shall issue a certificate of registration to the applicant  
21 if the department determines that the applicant meets the minimum requirements  
22 under this section and rules promulgated under sub. (13) for issuance of a certificate  
23 of registration and is satisfied that the applicant will comply with this section and  
24 those rules.

1           (d) The department may deny, suspend, revoke, restrict, or refuse to renew a  
2 certificate of registration if the department determines that any of the following  
3 apply:

4           1. The applicant or registrant is not the real party in interest with respect to  
5 the application or certificate of registration, and the real party in interest has  
6 previously been denied issuance or renewal of a certificate of registration, has had  
7 a certificate of registration suspended, revoked, or restricted, or is not qualified to  
8 receive a certificate of registration under par. (c).

9           2. A proprietor, managing partner, manager, or principal officer of the  
10 applicant, or an employee, agent, or representative of the applicant who supervises  
11 or transports traveling sales crew workers has been convicted of a disqualifying  
12 offense within the 5 years preceding the date of the application.

13           3. The applicant or registrant has made a material misrepresentation or false  
14 statement in the application for the certificate of registration.

15           4. The applicant or registrant has failed to notify the department of any change  
16 in the information submitted in the application as required under par. (e).

17           5. The applicant or registrant has failed to maintain proof of financial  
18 responsibility as required under sub. (4); failed to comply with the written disclosure  
19 statement requirements under sub. (5) (b); failed to pay wages, provide a statement,  
20 or keep, preserve, or furnish records as required under sub. (6); violated a safety  
21 standard under sub. (7); failed to maintain insurance coverage as required under  
22 sub. (8); engaged in a practice prohibited under sub. (9); employed a traveling sales  
23 crew worker in violation of sub. (11) (a) or (c) or failed to keep or furnish records as  
24 required under sub. (11) (b); failed to pay a penalty imposed under sub. (12) or to  
25 comply with an order of the department imposed as a result of a violation of this



1 section or any rule promulgated under sub. (13); or otherwise failed to comply with  
2 this section or any rule promulgated under sub. (13).

3 (e) If any change occurs in any of the information submitted to the department  
4 under par. (a), the registrant shall notify the department of that change within 30  
5 days after the change occurs.

6 (f) A registrant and all employees, agents, or representatives of a registrant  
7 who supervise or transport traveling sales crew workers shall carry at all times while  
8 engaging in traveling sales crew activities a copy of the registrant's certificate of  
9 registration and shall exhibit that copy upon the request of any deputy of the  
10 department, law enforcement officer, or person with whom the registrant, employee,  
11 agent, or representative is doing business. Failure to exhibit that copy upon that  
12 request is prima facie evidence of a violation of this section.

13 **(4) FINANCIAL RESPONSIBILITY.** (a) An applicant shall establish proof of its ability  
14 to pay any compensation owed to a traveling sales crew worker employed by the  
15 applicant and any penalties that may be imposed under sub. (12).

16 (b) An applicant shall prove its ability to pay under par. (a) by maintaining one  
17 of the following commitments in an amount approved by the department, but not less  
18 that \$10,000, and in a form approved by the department:

- 19 1. A bond.
- 20 2. A certificate of deposit.
- 21 3. An escrow account.
- 22 4. An irrevocable letter of credit.

23 (c) The commitment described in par. (b) shall be established in favor of or made  
24 payable to the department, for the benefit of the state and any traveling sales crew  
25 worker who does not receive the compensation earned by the worker. The applicant

1 shall file with the department any agreement, instrument, or other document  
2 necessary to enforce the commitment against the applicant or any relevant 3rd party,  
3 or both.

4 (5) DISCLOSURE STATEMENT. (a) At the time an individual is offered employment  
5 as a traveling sales crew worker or is otherwise recruited to work as a traveling sales  
6 crew worker, the employer shall provide the individual with a written disclosure  
7 statement of the terms of employment. If the individual accepts the offer of  
8 employment, the employer and the individual shall sign the written disclosure  
9 statement. A written disclosure statement shall include all of the following  
10 information:

11 1. The place or places of employment, stated with as much specificity as  
12 possible.

13 2. The compensation, including wage rates, commissions, bonuses, and contest  
14 awards, to be paid.

15 3. The type or types of work on which the individual may be employed.

16 4. The pay period and the manner in which compensation will be paid.

17 5. The number of days per week and hours per day that the individual may be  
18 required to engage in sales activities or related support work.

19 6. The nature and frequency of any employment-related meetings that the  
20 individual may be required to attend, the time of day of those meetings, and how  
21 compensation is paid for attendance at those meetings.

22 7. The period of employment, including the approximate beginning and ending  
23 dates of employment.

1           8. A description of the board, lodging, and other facilities to be provided by the  
2 employer to the individual and any costs to be charged to the individual for those  
3 facilities.

4           9. A description of the transportation to be provided by the employer to the  
5 individual and, if the employment will involve the storage, handling, or  
6 transportation of hazardous materials or may involve any other exposure to  
7 hazardous materials, a description of the hazardous materials.

8           10. Whether worker's compensation is provided and, if so, the name and  
9 telephone number of the employee, agent, or representative of the employer to whom  
10 notice of a claim for worker's compensation must be provided and the time period  
11 within which that notice must be provided.

12           (b) An employer of a traveling sales crew worker shall comply with the terms  
13 of a disclosure statement provided under par. (a). An employer may change the terms  
14 of a disclosure statement, but no change is effective until a supplemental disclosure  
15 statement is signed by the employer and the traveling sales crew worker. Any change  
16 to the terms of a disclosure statement may apply prospectively only.

17           **(6) PAYMENT OF COMPENSATION; DEDUCTIONS; STATEMENTS; RECORDS.** (a) An  
18 employer shall pay all compensation earned by a traveling sales crew worker on  
19 regular paydays designated in advance by the employer, but in no case less often than  
20 semimonthly. Compensation shall be paid in U.S. currency or by check or draft.

21           (b) An employer may deduct from a traveling sales crew worker's compensation  
22 the cost to the employer of furnishing board, lodging, or other facilities to the worker  
23 if the board, lodging, or other facilities are customarily furnished by the employer to  
24 the traveling sales crew workers of the employer; the amount deducted does not  
25 exceed the fair market value of the board, lodging, or other facilities and does not

1 include any profit to the employer; and the traveling sales crew worker has  
2 previously authorized the deduction by signing a written disclosure statement under  
3 sub. (5) (a) that includes a description of the board, lodging, and other facilities to be  
4 provided and any costs to be charged to the worker for those facilities.

5 (c) An employer shall provide with each payment of compensation to a traveling  
6 sales crew worker a written statement itemizing the amount of gross and net  
7 compensation paid to the worker and the amount of and reason for each deduction  
8 from the amount of gross compensation. An employer shall keep records of the  
9 information specified in this paragraph with respect to each traveling sales crew  
10 worker of the employer, shall preserve those records for 3 years after the worker  
11 leaves the employ of the employer, and shall furnish those records to the department  
12 on request.

13 (d) A traveling sales crew worker who is owed compensation may file a wage  
14 claim with the department under s. 109.09 (1) or may bring an action under s. 109.03  
15 (5) without first filing a wage claim with the department.

16 **(7) WORKER SAFETY.** (a) An employer of a traveling sales crew worker shall  
17 maintain and operate, or cause to be maintained and operated, any motor vehicle  
18 used to transport a traveling sales crew worker in compliance with all state and  
19 federal safety standards that are applicable to the maintenance and operation of the  
20 motor vehicle, including any additional safety standards relating specifically to the  
21 transportation of traveling sales crew workers prescribed by the department by rule  
22 promulgated under sub. (13). In prescribing those additional safety standards, the  
23 department shall consider all of the following:

24 1. The types of motor vehicles that are commonly used to transport traveling  
25 sales crew workers.

- 1           2. The safe passenger–carrying capacity of those motor vehicles.
- 2           3. The extent to which a proposed safety standard would cause an undue  
3 burden to traveling sales crew employers.
- 4           4. Any safety standards prescribed by the federal secretary of transportation  
5 under 49 USC 13101 to 14915, 49 USC 30101 to 30170, and 49 USC 31101 to 31317  
6 and any other chapter of title 49 of the United States Code that are applicable to the  
7 maintenance and operation of a motor vehicle that is commonly used to transport  
8 traveling sales crew workers.
- 9           (b) If the duties of a traveling sales crew worker include the storage, handling,  
10 or transportation of hazardous materials or may result in any other exposure of a  
11 traveling sales crew worker to hazardous materials, the employer shall ensure that  
12 the hazardous materials are stored, handled, and transported, and that the traveling  
13 sales crew worker is trained in the safe storage, handling, and transportation of  
14 hazardous materials, in accordance with all state and federal safety standards that  
15 are applicable to the storage, handling, and transportation of hazardous materials  
16 or to exposure to hazardous materials, including any additional safety standards  
17 relating specifically to the storage, handling, and transportation of hazardous  
18 materials by traveling sales crew workers or to the exposure of traveling sales crews  
19 to hazardous materials prescribed by the department by rule promulgated under  
20 sub. (13). In prescribing those additional safety standards, the department shall  
21 consider all of the following:
- 22           1. The types of hazardous materials that are included in products commonly  
23 sold by traveling sales crews.
- 24           2. The extent to which a proposed safety standard would cause an undue  
25 burden to traveling sales crew employers.

1           3. Any safety standards prescribed by the federal secretary of transportation  
2 under 49 USC 5101 to 5128 or by the federal occupational safety and health  
3 administration under 29 USC 651 to 678 that are applicable to the storage, handling,  
4 and transportation of hazardous materials by a traveling sales crew worker or to any  
5 other exposure of a traveling sales crew worker to hazardous materials.

6           **(8) INSURANCE COVERAGE.** The employer of a traveling sales crew worker shall  
7 have in force a policy of insurance that insures the employer, in an amount prescribed  
8 by the department by rule promulgated under sub. (13), against liability for damages  
9 to persons and property arising out of the ownership or operation by the employer  
10 or by any employee, agent, or representative of the employer of a motor vehicle that  
11 is used to transport a traveling sales crew worker and a policy of insurance that  
12 insures the employer, in an amount prescribed by the department by rule  
13 promulgated under sub. (13), against liability for damages to persons and property  
14 arising out of any negligent act or omission of the employer or of any employee, agent,  
15 or representative of the employer. If the employer is required under s. 102.28 (2) to  
16 provide worker's compensation coverage for its employees, the employer shall also  
17 provide that coverage.

18           **(9) PROHIBITED PRACTICES.** No employer of a traveling sales crew worker and  
19 no employee, agent, or representative of that employer who supervises or transports  
20 traveling sales crew workers may do any of the following:

21           (a) Employ or permit to work as a traveling sales crew worker a person under  
22 18 years of age or employ or permit to work as a traveling sales crew worker a person  
23 18 years of age or over who has been adjudged incompetent under ch. 54 without the  
24 permission of the person's guardian.

1           (b) Require a traveling sales crew worker to engage in any in-person sales or  
2 solicitation activities before 9 a.m. or after 9 p.m.

3           (c) Consider a traveling sales crew worker to be an independent contractor  
4 rather than an employee.

5           (d) Require a traveling sales crew worker to purchase any goods or services  
6 solely from the employer or to pay any of the employer's business expenses, except  
7 as permitted under sub. (6) (b).

8           (e) Abandon a traveling sales crew worker who is unable to work due to illness  
9 or injury or who is discharged from employment for reasons other than misconduct  
10 without providing for the return of the traveling sales crew worker to his or her  
11 permanent place of residence.

12           (f) Abandon a traveling sales crew worker who has been arrested and is being  
13 held in custody in connection with a violation of sub. (11) (a) 3. or a local ordinance  
14 regulating that conduct.

15           (g) Require a traveling sales crew worker to relinquish custody of any of his or  
16 her personal property to the employer, to any employee, agent, or representative of  
17 the employer who supervises or transports traveling sales crew workers, or to any  
18 other traveling sales crew worker of the employer.

19           (h) Prohibit or restrict a traveling sales crew worker from contacting any family  
20 member, friend, or other person while traveling with a traveling sales crew.

21           (i) Intentionally inflict or threaten to inflict any bodily harm on a traveling  
22 sales crew worker or damage to the property of a traveling sales crew worker as a  
23 means of discipline or motivation.

1           (j) Advise or counsel a traveling sales crew worker to make false  
2 representations to a person to whom he or she is offering goods or services concerning  
3 his or her motivation for selling those goods or services.

4           (k) Discharge or discriminate against any person for opposing a practice  
5 prohibited under this section. Section 111.322 (2m) applies to discharge and other  
6 discriminatory acts arising in connection with any proceeding under this section.

7           **(10) CHILD SUPPORT; DELINQUENT TAXES.** (a) 1. Except as provided in subd. 3.,  
8 the department shall require each applicant for a certificate of registration who is  
9 an individual to provide the department with the applicant's social security number,  
10 and shall require each applicant for a certificate of registration who is not an  
11 individual to provide the department with the applicant's federal employer  
12 identification number, when initially applying for or applying to renew the certificate  
13 of registration.

14           2. If an applicant who is an individual fails to provide the applicant's social  
15 security number to the department or if an applicant who is not an individual fails  
16 to provide the applicant's federal employer identification number to the department,  
17 the department may not issue or renew a certificate of registration to or for the  
18 applicant unless the applicant is an individual who does not have a social security  
19 number and the applicant submits a statement made or subscribed under oath or  
20 affirmation as required under subd. 3.

21           3. If an applicant who is an individual does not have a social security number,  
22 the applicant shall submit a statement made or subscribed under oath or affirmation  
23 to the department that the applicant does not have a social security number. The  
24 form of the statement shall be prescribed by the department. A certificate of



1 registration issued in reliance upon a false statement submitted under this  
2 subdivision is invalid.

3 4. The subunit of the department that obtains a social security number or a  
4 federal employer identification number under subd. 1. may not disclose the social  
5 security number or the federal employer identification number to any person except  
6 to the department of revenue for the sole purpose of requesting certifications under  
7 s. 73.0301 or on the request of the subunit of the department that administers the  
8 child and spousal support program under s. 49.22 (2m).

9 (b) The department shall deny, suspend, restrict, refuse to renew, or otherwise  
10 withhold a certificate of registration for failure of the applicant or registrant to pay  
11 court-ordered payments of child or family support, maintenance, birth expenses,

23 (j) Academic staff of the University of Wisconsin–Extension.

24 (jm) Academic staff of the University of Wisconsin–Eau Claire.

25 (k) Academic staff of the University of Wisconsin–Green Bay.

1 (km) Academic staff of the University of Wisconsin–La Crosse.

2 (L) Academic staff of the University of Wisconsin–Oshkosh.

3 (Lm) Academic staff of the University of Wisconsin–Parkside.

4 (m) Academic staff of the University of Wisconsin–Platteville.

5 (mm) Academic staff of the University of Wisconsin–River Falls.

6 (n) Academic staff of the University of Wisconsin–Stevens Point.

7 (nm) Academic staff of the University of Wisconsin–Stout.

8 (o) Academic staff of the University of Wisconsin–Superior.

9 (om) Academic staff of the University of Wisconsin–Whitewater.

10 (p) Academic staff of the University of Wisconsin Colleges.

11 **(2)** (a) Notwithstanding sub. (1), 2 or more collective bargaining units described  
12 under sub. (1) (a) to (p) may be combined into a single unit. If 2 or more collective  
13 bargaining units seek to combine into a single collective bargaining unit, the  
14 commission shall, upon the petition of at least 30 percent of the employees in each  
15 unit, hold an election to determine whether a majority of those employees voting in  
16 each unit desire to combine into a single unit. A combined collective bargaining unit  
17 shall be formed including all employees from each of those units in which a majority  
18 of the employees voting in the election approve a combined unit. The combined  
19 collective bargaining unit shall be formed immediately if there is no existing  
20 collective bargaining agreement in force in any of the units to be combined. If there  
21 is a collective bargaining agreement in force at the time of the election in any of the  
22 collective bargaining units to be combined, the combined unit shall be formed upon  
23 expiration of the last agreement for the units concerned.

24 (b) If 2 or more collective bargaining units have combined under par. (a), the  
25 commission shall, upon petition of at least 30 percent of the employees in any of the

1 original units, hold an election of the employees in the original unit to determine  
2 whether the employees in that unit desire to withdraw from the combined collective  
3 bargaining unit. If a majority of the employees voting desire to withdraw from the  
4 combined collective bargaining unit, separate units consisting of the unit in which  
5 the election was held and a unit composed of the remainder of the combined unit shall  
6 be formed. The new collective bargaining units shall be formed immediately if there  
7 is no collective bargaining agreement in force for the combined unit. If there is a  
8 collective bargaining agreement in force for the combined collective bargaining unit,  
9 the new units shall be formed upon the expiration of the agreement. While there is  
10 a collective bargaining agreement in force for the combined collective bargaining  
11 unit, a petition for an election under this paragraph may be filed only during October  
12 in the calendar year prior to the expiration of the agreement.

13 **(3)** The commission shall assign employees to the appropriate collective  
14 bargaining units described under sub. (1) or (2).

15 **(4)** Any labor organization may petition for recognition as the exclusive  
16 representative of a collective bargaining unit described under sub. (1) or (2) in  
17 accordance with the election procedures under s. 111.990 if the petition is  
18 accompanied by a 30 percent showing of interest in the form of signed authorization  
19 cards. Any additional labor organization seeking to appear on the ballot shall file a  
20 petition within 60 days of the date of filing of the original petition and prove, through  
21 signed authorization cards, that at least 10 percent of the employees in the collective  
22 bargaining unit want it to be their representative.

23 **(5)** Although academic staff supervisors are not considered employees for the  
24 purpose of this subchapter, the commission may consider a petition for a statewide  
25 collective bargaining unit consisting of academic staff supervisors, but the

1 representative of the supervisors may not be affiliated with any labor organization  
2 representing employees. For purposes of this subsection, affiliation does not include  
3 membership in a national, state, county, or municipal federation of national or  
4 international labor organizations. The certified representative of the supervisors  
5 may not bargain collectively with respect to any matter other than wages and fringe  
6 benefits.

7 **111.990 Representatives and elections. (1)** A representative chosen for the  
8 purposes of collective bargaining by a majority of the employees voting in a collective  
9 bargaining unit shall be the exclusive representative of all of the employees in such  
10 unit for the purposes of collective bargaining. Any individual employee, or any  
11 minority group of employees in any collective bargaining unit, may present any  
12 grievance to the employer in person, or through representatives of their own  
13 choosing, and the employer shall confer with the individual employee or group of  
14 employees with respect to the grievance if the majority representative has been  
15 afforded the opportunity to be present at the conference. Any adjustment resulting  
16 from such a conference may not be inconsistent with the conditions of employment  
17 established by the majority representative and the employer.

18 **(2)** Whenever a question arises concerning the representation of employees in  
19 a collective bargaining unit, the commission shall determine the representation by  
20 taking a secret ballot of the employees and certifying in writing the results to the  
21 interested parties and to the board. There shall be included on any ballot for the  
22 election of representatives the names of all labor organizations having an interest  
23 in representing the employees participating in the election as indicated in petitions  
24 filed with the commission. The name of any existing representative shall be included  
25 on the ballot without the necessity of filing a petition. The commission may exclude

1 from the ballot one who, at the time of the election, stands deprived of his or her rights  
2 under this subchapter by reason of a prior adjudication of his or her having engaged  
3 in an unfair labor practice. The ballot shall be so prepared as to permit a vote against  
4 representation by anyone named on the ballot. For elections in a collective  
5 bargaining unit composed of employees who are members of the faculty or academic  
6 staff, whenever more than one representative qualifies to appear on the ballot, the  
7 ballot shall be prepared to provide separate votes on 2 questions. The first question  
8 shall be: “Shall the employees of the ... (name of collective bargaining unit)  
9 participate in collective bargaining?”. The 2nd question shall be: “If the employees  
10 of the ... (name of collective bargaining unit) elect to participate in collective  
11 bargaining, which labor organization do you favor to act as representative of the  
12 employees?”. The 2nd question shall not include a choice for no representative. All  
13 employees in the collective bargaining unit may vote on both questions. Unless a  
14 majority of those employees voting in the election vote to participate in collective  
15 bargaining, no votes for a particular representative may be counted. If a majority  
16 of those employees voting in the election vote to participate in collective bargaining,  
17 the ballots for representatives shall be counted. The commission’s certification of the  
18 results of any election is conclusive as to the findings included therein unless  
19 reviewed under s. 111.07 (8).

20 **(3)** Whenever an election has been conducted under sub. (2) in which a majority  
21 of the employees voting indicate a desire to participate in collective bargaining but  
22 in which no named representative is favored by a majority of the employees voting,  
23 the commission may, if requested by a party to the proceeding within 30 days from  
24 the date of the certification of the results of the election, conduct a runoff election.

1 In that runoff election, the commission shall drop from the ballot the name of the  
2 representative who received the least number of votes at the original election.

3 (4) While a collective bargaining agreement between a labor organization and  
4 an employer is in force under this subchapter, a petition for an election in the  
5 collective bargaining unit to which the agreement applies may be filed only during  
6 October in the calendar year prior to the expiration of that agreement. An election  
7 held under that petition may be held only if the petition is supported by proof that  
8 at least 30 percent of the employees in the collective bargaining unit desire a change  
9 or discontinuance of existing representation. Within 60 days of the time that an  
10 original petition is filed, another petition may be filed supported by proof that at least  
11 10 percent of the employees in the same collective bargaining unit desire a different  
12 representative. If a majority of the employees in the collective bargaining unit vote  
13 for a change or discontinuance of representation by any named representative, the  
14 decision takes effect upon expiration of any existing collective bargaining agreement  
15 between the employer and the existing representative.

16 **111.991 Unfair labor practices. (1)** It is an unfair labor practice for an  
17 employer individually or in concert with others:

18 (a) To interfere with, restrain, or coerce employees in the exercise of their rights  
19 guaranteed under s. 111.97.

20 (b) Except as otherwise provided in this paragraph, to initiate, create,  
21 dominate, or interfere with the formation or administration of any labor or employee  
22 organization or contribute financial support to it. Except as provided in ss. 40.02 (22)  
23 (e) and 40.23 (1) (f) 4., no change in any law affecting the Wisconsin Retirement  
24 System under ch. 40 and no action by the employer that is authorized by such a law  
25 is a violation of this paragraph unless an applicable collective bargaining agreement

1 specifically prohibits the change or action. No such change or action affects the  
2 continuing duty to bargain collectively regarding the Wisconsin Retirement System  
3 under ch. 40 to the extent required by s. 111.998. It is not an unfair labor practice  
4 for the employer to reimburse an employee at his or her prevailing wage rate for the  
5 time spent during the employee's regularly scheduled hours conferring with the  
6 employer's officers or agents and for attendance at commission or court hearings  
7 necessary for the administration of this subchapter.

8 (c) To encourage or discourage membership in any labor organization by  
9 discrimination in regard to hiring, tenure, or other terms or conditions of  
10 employment. This paragraph does not apply to fair-share or maintenance of  
11 membership agreements.

12 (d) To refuse to bargain collectively on matters set forth in s. 111.998 with a  
13 representative of a majority of its employees in an appropriate collective bargaining  
14 unit. Whenever the employer has a good faith doubt as to whether a labor  
15 organization claiming the support of a majority of its employees in an appropriate  
16 collective bargaining unit does in fact have that support, it may file with the  
17 commission a petition requesting an election as to that claim. The employer is not  
18 considered to have refused to bargain until an election has been held and the results  
19 of the election are certified to the employer by the commission. A violation of this  
20 paragraph includes the refusal to execute a collective bargaining agreement  
21 previously orally agreed upon.

22 (e) To violate any collective bargaining agreement previously agreed upon by  
23 the parties with respect to wages, hours, and conditions of employment affecting the  
24 employees, including an agreement to arbitrate or to accept the terms of an

1 arbitration award, when previously the parties have agreed to accept such award as  
2 final and binding upon them.

3 (f) To deduct labor organization dues from an employee's earnings, unless the  
4 employer has been presented with an individual order therefor, signed by the  
5 employee personally, and terminable by at least the end of any year of its life or  
6 earlier by the employee giving at least 30 but not more than 120 days written notice  
7 of such termination to the employer and to the representative labor organization,  
8 except if there is a fair-share or maintenance of membership agreement in effect.  
9 The employer shall give notice to the labor organization of receipt of such notice of  
10 termination.

11 **(1m)** Notwithstanding sub. (1), it is not an unfair labor practice for the board  
12 to implement changes in salaries or conditions of employment for members of the  
13 faculty or academic staff at one institution, and not for other members of the faculty  
14 or academic staff at another institution, but this may be done only if the differential  
15 treatment is based on comparisons with the compensation and working conditions  
16 of employees performing similar services for comparable higher education  
17 institutions or based upon other competitive factors.

18 **(2)** It is unfair practice for an employee individually or in concert with others:

19 (a) To coerce or intimidate an employee in the enjoyment of the employee's legal  
20 rights, including those guaranteed under s. 111.97.

21 (b) To coerce, intimidate, or induce any officer or agent of the employer to  
22 interfere with any of the employer's employees in the enjoyment of their legal rights  
23 including those guaranteed under s. 111.97 or to engage in any practice with regard  
24 to its employees which would constitute an unfair labor practice if undertaken by the  
25 officer or agent on the officer's or agent's own initiative.



1 (c) To refuse to bargain collectively on matters specified in s. 111.998 with the  
2 authorized officer or agent of the employer that is the recognized or certified  
3 exclusive collective bargaining representative of employees in an appropriate  
4 collective bargaining unit. Such refusal to bargain shall include a refusal to execute  
5 a collective bargaining agreement previously orally agreed upon.

6 (d) To violate the provisions of any written agreement with respect to terms and  
7 conditions of employment affecting employees, including an agreement to arbitrate  
8 or to accept the terms of an arbitration award, when previously the parties have  
9 agreed to accept such awards as final and binding upon them.

10 (e) To engage in, induce, or encourage any employees to engage in a strike or  
11 a concerted refusal to work or perform their usual duties as employees.

12 (f) To coerce or intimidate a supervisory employee, officer, or agent of the  
13 employer, working at the same trade or profession as the employer's employees, to  
14 induce the person to become a member of or act in concert with the labor organization  
15 of which the employee is a member

16 **(3)** It is an unfair labor practice for any person to do or cause to be done on  
17 behalf of or in the interest of employers or employees, or in connection with or to  
18 influence the outcome of any controversy as to employment relations, any act  
19 prohibited by subs. (1) and (2).

20 **(4)** Any controversy concerning unfair labor practices may be submitted to the  
21 commission as provided in s. 111.07, except that the commission shall schedule a  
22 hearing on complaints involving alleged violations of sub. (2) (e) within 3 days after  
23 filing of a complaint, and notice shall be given to each party interested by service on  
24 the party personally, or by telegram, advising the party of the nature of the complaint  
25 and of the date, time, and place of hearing. The commission may appoint a substitute

1 tribunal to hear unfair labor practice charges by either appointing a 3-member panel  
2 or submitting a 7-member panel to the parties and allowing each to strike 2 names.  
3 Any such panel shall report its finding to the commission for appropriate action.

4 **111.992 Fair-share and maintenance of membership agreements. (1)**

5 (a) No fair-share or maintenance of membership agreement may become effective  
6 unless authorized by a referendum. The commission shall order a referendum  
7 whenever it receives a petition supported by proof that at least 30 percent of the  
8 employees or supervisors specified in s. 111.98 (5) in a collective bargaining unit  
9 desire that a fair-share or maintenance of membership agreement be entered into  
10 between the employer and a labor organization. A petition may specify that a  
11 referendum is requested on a maintenance of membership agreement only, in which  
12 case the ballot shall be limited to that question.

13 (b) For a fair-share agreement to be authorized, at least two-thirds of the  
14 eligible employees or supervisors voting in a referendum shall vote in favor of the  
15 agreement. For a maintenance of membership agreement to be authorized, at least  
16 a majority of the eligible employees or supervisors voting in a referendum shall vote  
17 in favor of the agreement. In a referendum on a fair-share agreement, if less than  
18 two-thirds but more than one-half of the eligible employees or supervisors vote in  
19 favor of the agreement, a maintenance of membership agreement is authorized.

20 (c) If a fair-share or maintenance of membership agreement is authorized in  
21 a referendum, the employer shall enter into such an agreement with the labor  
22 organization named on the ballot in the referendum. Each fair-share or  
23 maintenance of membership agreement shall contain a provision requiring the  
24 employer to deduct the amount of dues as certified by the labor organization from the  
25 earnings of the employees or supervisors affected by the agreement and to pay the

1 amount so deducted to the labor organization. Unless the parties agree to an earlier  
2 date, the agreement shall take effect 60 days after certification by the commission  
3 that the referendum vote authorized the agreement. The employer shall be held  
4 harmless against any claims, demands, suits and other forms of liability made by  
5 employees or supervisors or local labor organizations which may arise for actions  
6 taken by the employer in compliance with this section. All such lawful claims,  
7 demands, suits and other forms of liability are the responsibility of the labor  
8 organization entering into the agreement.

9 (d) Under each fair-share or maintenance of membership agreement, an  
10 employee or supervisor who has religious convictions against dues payments to a  
11 labor organization based on teachings or tenets of a church or religious body of which  
12 he or she is a member shall, on request to the labor organization, have his or her dues  
13 paid to a charity mutually agreed upon by the employee or supervisor and the labor  
14 organization. Any dispute concerning this paragraph may be submitted to the  
15 commission for adjudication.

16 **(2)** (a) Once authorized, a fair-share or maintenance of membership  
17 agreement shall continue in effect, subject to the right of the employer or labor  
18 organization concerned to petition the commission to conduct a new referendum.  
19 Such a petition must be supported by proof that at least 30 percent of the employees  
20 or supervisors in the collective bargaining unit desire that the fair-share or  
21 maintenance of membership agreement be discontinued. Upon so finding, the  
22 commission shall conduct a new referendum. If the continuance of the fair-share or  
23 maintenance of membership agreement is approved in the referendum by at least the  
24 percentage of eligible voting employees or supervisors required for its initial  
25 authorization, it shall be continued in effect, subject to the right of the employer or

1 labor organization to later initiate a further vote following the procedure prescribed  
2 in this subsection. If the continuation of the agreement is not supported in any  
3 referendum, it is considered terminated at the termination of the collective  
4 bargaining agreement, or one year from the date of the certification of the result of  
5 the referendum, whichever is earlier.

6 (b) The commission shall declare any fair-share or maintenance of  
7 membership agreement suspended upon such conditions and for such time as the  
8 commission decides whenever it finds that the labor organization involved has  
9 refused on the basis of race, color, sexual orientation, or creed to receive as a member  
10 any employee or supervisor in the collective bargaining unit involved, and the  
11 agreement shall be made subject to the findings and orders of the commission. Any  
12 of the parties to the agreement, or any employee or supervisor covered under the  
13 agreement, may come before the commission, as provided in s. 111.07, and petition  
14 the commission to make such a finding.

15 (3) A stipulation for a referendum executed by an employer and a labor  
16 organization may not be filed until after the representation election has been held  
17 and the results certified.

18 (4) The commission may, under rules adopted for that purpose, appoint as its  
19 agent an official of a state agency whose employees are entitled to vote in a  
20 referendum to conduct a referendum under this section.

21 **111.993 Grievance arbitration.** (1) Parties to the dispute pertaining to the  
22 interpretation of a collective bargaining agreement may agree in writing to have the  
23 commission or any other appointing state agency serve as arbitrator or may  
24 designate any other competent, impartial, and disinterested persons to so serve.  
25 Such arbitration proceedings shall be governed by ch. 788.

1           **(2)** The board shall charge an institution for the employer’s share of the cost  
2 related to grievance arbitration under sub. (1) for any arbitration that involves one  
3 or more employees of the institution. Each institution so charged shall pay the  
4 amount that the board charges from the appropriation account or accounts used to  
5 pay the salary of the grievant. Funds received under this subsection shall be credited  
6 to the appropriation account under s. 20.545 (1) (km).

7           **111.994 Mediation.** The commission may appoint any competent, impartial,  
8 disinterested person to act as mediator in any labor dispute either upon its own  
9 initiative or upon the request of one of the parties to the dispute. It is the function  
10 of a mediator to bring the parties together voluntarily under such favorable auspices  
11 as will tend to effectuate settlement of the dispute, but neither the mediator nor the  
12 commission shall have any power of compulsion in mediation proceedings.

13           **111.995 Fact–finding. (1)** If a dispute has not been settled after a reasonable  
14 period of negotiation and after the settlement procedures, if any, established by the  
15 parties have been exhausted, the representative that has been certified by the  
16 commission after an election, as the exclusive representative of employees in an  
17 appropriate bargaining unit, and the employer, its officers, and agents, after a  
18 reasonable period of negotiation, are deadlocked with respect to any dispute between  
19 them arising in the collective bargaining process, the parties jointly may petition the  
20 commission, in writing, to initiate fact–finding under this section, and to make  
21 recommendations to resolve the deadlock.

22           **(2)** Upon receipt of a petition to initiate fact–finding, the commission shall  
23 make an investigation with or without a formal hearing, to determine whether a  
24 deadlock in fact exists. The commission shall certify the results of the investigation.  
25 If the commission decides that fact–finding should be initiated, it shall appoint a

1 qualified, disinterested person or, when jointly requested by the parties, a 3–member  
2 panel to function as a fact finder.

3       **(3)** The fact finder may establish dates and place of hearings and shall conduct  
4 the hearings under rules established by the commission. Upon request, the  
5 commission shall issue subpoenas for hearings conducted by the fact finder. The fact  
6 finder may administer oaths. Upon completion of the hearing, the fact finder shall  
7 make written findings of fact and recommendations for solution of the dispute and  
8 shall cause the same to be served on the parties and the commission. In making  
9 findings and recommendations, the fact finder shall take into consideration among  
10 other pertinent factors the principles vital to the public interest in efficient and  
11 economical governmental administration. Upon the request of either party the fact  
12 finder may orally present the recommendations in advance of service of the written  
13 findings and recommendations. Cost of fact–finding proceedings shall be divided  
14 equally between the parties. At the time the fact finder submits a statement of his  
15 or her costs to the parties, the fact finder shall submit a copy thereof to the  
16 commission at its Madison office.

17       **(4)** A fact finder may mediate a dispute at any time prior to the issuance of the  
18 fact finder’s recommendations.

19       **(5)** Within 30 days of the receipt of the fact finder’s recommendations or within  
20 a time period mutually agreed upon by the parties, each party shall advise the other,  
21 in writing, as to the party’s acceptance or rejection, in whole or in part, of the fact  
22 finder’s recommendations and, at the same time, send a copy of the notification to  
23 the commission at its Madison office. Failure to comply with this subsection, by the  
24 employer or employee representative, is a violation of s. 111.991 (1) (d) or (2) (c).

1           **111.996 Strike prohibited. (1)** Upon establishing that a strike is in progress,  
2 the employer may either seek an injunction or file an unfair labor practice charge  
3 with the commission under s. 111.991 (2) (e) or both. It is the responsibility of the  
4 board to decide whether to seek an injunction or file an unfair labor practice charge.  
5 The existence of an administrative remedy does not constitute grounds for denial of  
6 injunctive relief.

7           **(2)** The occurrence of a strike and the participation in the strike by an employee  
8 do not affect the rights of the employer, in law or in equity, to deal with the strike,  
9 including all of the following:

10           (a) The right to impose discipline, including discharge, or suspension without  
11 pay, of any employee participating in the strike.

12           (b) The right to cancel the reinstatement eligibility of any employee engaging  
13 in the strike.

14           (c) The right of the employer to request the imposition of fines, either against  
15 the labor organization or the employee engaging in the strike, or to sue for damages  
16 because of such strike activity.

17           **111.997 Management rights.** Nothing in this subchapter shall interfere with  
18 the right of the board, in accordance with this subchapter to do any of the following:

19           **(1)** Carry out the statutory mandate and goals assigned to the board by the  
20 most appropriate and efficient methods and means and utilize personnel in the most  
21 appropriate and efficient manner possible.

22           **(2)** Suspend, demote, discharge, or take other appropriate disciplinary action  
23 against the employee; or to lay off employees in the event of lack of work or funds or  
24 under conditions where continuation of such work would be inefficient and  
25 nonproductive.

1           **111.998 Subjects of bargaining. (1)** (a) Except as provided in pars. (b) to (f),  
2 matters subject to collective bargaining to the point of impasse are salaries; fringe  
3 benefits consistent with sub. (2); and hours and conditions of employment.

4           (b) The board is not required to bargain on management rights under s.  
5 111.997, except that procedures for the adjustment or settlement of grievances or  
6 disputes arising out of any type of disciplinary action in s. 111.997 (2) is a subject of  
7 bargaining.

8           (c) The board is prohibited from bargaining on matters contained in sub. (2).

9           (d) Except as provided in sub. (2) (d) and (e) and ss. 40.02 (22) (e) and 40.23 (1)  
10 (f) 4., all laws governing the Wisconsin Retirement System under ch. 40 and all  
11 actions of the board that are authorized under any such law which apply to  
12 nonrepresented individuals employed by the state shall apply to similarly situated  
13 employees, unless otherwise specifically provided in a collective bargaining  
14 agreement that applies to those employees.

15           (e) Demands relating to retirement and group insurance shall be submitted to  
16 the board at least one year prior to commencement of negotiations.

17           (f) The board is not required to bargain on matters related to employee  
18 occupancy of houses or other lodging provided by the state.

19           **(2)** The board is prohibited from bargaining on:

20           (a) The mission and goals of the board as set forth in the statutes; the  
21 diminution of the right of tenure provided the faculty under s. 36.13, the rights  
22 granted faculty under s. 36.09 (4) and academic staff under s. 36.09 (4m), or the  
23 rights of appointment provided academic staff under s. 36.15; or academic freedom.

24           (b) Amendments to this subchapter.



1 (c) Family leave and medical leave rights below the minimum afforded under  
2 s. 103.10. Nothing in this paragraph prohibits the board from bargaining on rights  
3 to family leave or medical leave which are more generous to the employee than the  
4 rights provided under s. 103.10.

5 (d) An increase in benefit adjustment contribution rates under s. 40.05 (2n) (a)  
6 3.

7 (e) The rights of employees to have retirement benefits computed under s.  
8 40.30.

9 (f) Honesty testing requirements that provide fewer rights and remedies to  
10 employees than are provided under s. 111.37.

11 (h) Creditable service to which s. 40.285 (2) (b) 4. applies.

12 (i) Compliance with the health benefit plan requirements under ss. 632.746 (1)  
13 to (8) and (10), 632.747, and 632.748.

14 (j) Compliance with the insurance requirements under s. 631.95.

15 (k) The definition of earnings under s. 40.02 (22).

16 (L) The maximum benefit limitations under s. 40.31

17 (m) The limitations on contributions under s. 40.32.

18 (n) The provision to employees of the health insurance coverage required under  
19 s. 632.895 (11) to (14).

17 immediate family do not meet the criteria under sub. (1) (a) and (b), but do meet the  
18 criteria under sub. (1) (c) to (e) and the person is gainfully employed in this state, as  
19 defined by the board, the person and the members of the person's immediate family  
20 are eligible to participate in the plan.

21           **(3) DEPENDENT CHILDREN.** If a child under age 18 resides with his or her parent  
22 in this state but the parent does not yet meet the residency requirement under sub.  
23 (1) (a), the child is eligible to participate in the plan regardless of the length of time  
24 the child has resided in this state.

1           **(4) PREGNANT WOMEN.** A pregnant woman who resides in this state who does  
2 not yet meet the residency requirement under sub. (1) (a) is eligible to participate in  
3 the plan regardless of the length of time the pregnant woman has resided in this  
4 state.

5           **(5) COLLECTIVE BARGAINING AGREEMENT.** A person who is eligible to participate  
6 in the plan under sub. (1), (2), (3), or (4) and who receives health care coverage under  
7 a collective bargaining agreement that is in effect on January 1, 2009, is not eligible  
8 to participate in the plan until the day on which the collective bargaining agreement  
9 expires or the day on which the collective bargaining agreement is extended,  
10 modified, or renewed.

11           **(6) WAIVER REQUEST.** (a) In this subsection, “department” means the  
12 department of health and family services.

13           (b) 1. The department shall develop a request for a waiver from the secretary  
14 of the federal department of health and human services to provide coverage under  
15 the plan to individuals who are eligible for Medical Assistance under subch. IV of ch.  
16 49 in the low-income families category, as determined by the department, and to  
17 individuals who are eligible for health care coverage under the Badger Care health  
18 care program under s. 49.665. The waiver request shall be written so as to allow the  
19 use of federal financial participation to fund, to the maximum extent possible, health  
20 care coverage under the plan for the individuals specified in this subdivision.

21           2. The department shall, not later than July 1, 2008, submit the waiver request  
22 developed under subd. 1. to a special legislative committee that shall be comprised  
23 of the members of the joint committee on finance and the members of the standing  
24 committees of the senate and the assembly with subject matter jurisdiction over



1 health issues. The special legislative committee shall have 60 days to review and  
2 comment to the department on the waiver request.

3 (c) Except as required under par. (b), the department may develop waiver  
4 requests to the appropriate federal agencies to permit funds from federal health care  
5 services programs to be used for health care coverage for persons under the plan.

6 **(7) DEFINITIONS OF TERMS.** For purposes of this chapter, the board shall define  
7 all of the following terms:

8 (a) Place of permanent abode.

9 (b) Substantial presence this state. In defining “substantial presence in this  
10 state,” the board shall consider such factors as the amount of time per year that an  
11 individual is actually present in the state and the amount of taxes that an individual  
12 pays in this state, except that, if the individual attends school outside of this state  
13 and is under 23 years of age, the factors shall include the amount of time that the  
14 individual’s parent or guardian is actually present in the state and the amount of  
15 taxes that the individual’s parent or guardian pays in this state, and if the individual  
16 is in active service with the U.S. armed forces outside of this state, the factors shall  
17 include the amount of time that the individual’s parent, guardian, or spouse is  
18 actually present in the state and the amount of taxes that the individual’s parent,  
19 guardian, or spouse pays in this state.

20 (c) Immediate family.

21 (d) Gainfully employed. The definition shall include employment by persons  
22 who are self-employed and persons who work on farms.

23 **260.12 Office of outreach, enrollment, and advocacy. (1) ESTABLISHMENT.**  
24 The board shall establish an office of outreach, enrollment, and advocacy. The office  
25 shall contract with nonprofit organizations to perform the outreach, enrollment, and

1 advocacy functions specified in this section, and to review the health care payment  
2 and services records of persons who are participating, or who are eligible to  
3 participate, in the plan and who have provided the office with informed consent for  
4 the review. The office may not contract with any organization under this subsection  
5 that provides services under the plan or that has any other conflict of interest, as  
6 described in sub. (3).

7 **(2) DUTIES.** The office of outreach, enrollment, and advocacy shall do all of the  
8 following:

9 (a) Engage in aggressive outreach to enroll eligible persons and participants  
10 in their choice of health care coverage under the plan.

11 (b) Assist eligible persons in choosing health care coverage by examining cost,  
12 quality, and geographic coverage information regarding their choice of available  
13 networks or providers.

14 (c) Inform plan participants of the role they can play in holding down health  
15 care costs by taking advantage of preventive care, enrolling in chronic disease  
16 management programs if appropriate, responsibly utilizing medical services, and  
17 engaging in healthy lifestyles. The office shall inform participants of networks or  
18 workplaces where healthy lifestyle incentives are in place.

19 (d) At the direction of the board, establish a process for resolving disputes with  
20 providers.

21 (e) Act as an advocate for plan participants having questions, difficulties, or  
22 complaints about their health care services or coverage, including investigating and  
23 attempting to resolve the complaint. Investigation should include, when  
24 appropriate, consulting with the health care advisory committee under s. 260.49  
25 regarding best practice guidelines.

1 (f) If a participant's complaint cannot be successfully resolved, inform the  
2 participant of any legal or other means of recourse for his or her complaint. If the  
3 complaint involves a dispute over eligibility or other determinations made by the  
4 board, the participant shall be directed to the appeals process for board decisions.

5 (g) Provide information to the public, agencies, legislators, and others  
6 regarding problems and concerns of plan participants and, in consultation with the  
7 health care advisory committee under s. 260.49, make recommendations for  
8 resolving those problems and concerns.

9 (h) Ensure that plan participants have timely access to the services provided  
10 by the office.

11 **(3) CONFLICT OF INTEREST LIMITATION.** The office and its employees and  
12 contractors shall not have any conflict of interest relating to the performance of their  
13 duties. There is a conflict of interest if, with respect to the office's director, employees,  
14 or contractors, or a person affiliated with the office's director, employees, or  
15 contractors, any of the following exists:

16 (a) Direct involvement in the licensing, certification, or accreditation of a  
17 health care facility, health insurer, or health care provider.

18 (b) Direct ownership interest or investment interest in a health care facility,  
19 health insurer, or health care provider.

20 (c) Employment by, or participation in, the management of a health care  
21 facility, health insurer, or health care provider.

22 (d) Receipt of, or having the right to receive, directly or indirectly, remuneration  
23 under a compensation arrangement with a health care facility, health insurer, or  
24 health care provider.

1           **260.15 Benefits. (1) GENERALLY.** The board shall establish a health care plan  
2 that will take effect on January 1, 2009. The plan shall provide the same benefits  
3 as those that were in effect as of January 1, 2007, under the state employee health  
4 plan under s. 40.51 (6). The board may adjust the plan benefits to provide additional  
5 cost-effective treatment options if there is evidence-based research that the options  
6 are likely to reduce health care costs, avoid health risks, or result in better health  
7 outcomes.

8           **(2) ADDITIONAL BENEFITS.** In addition to the benefit requirements under sub.  
9 (1), the plan shall provide coverage for mental health services and alcohol or other  
10 drug abuse treatment to the same extent as the plan covers treatment for physical  
11 conditions and coverage for preventive dental care for children up to 18 years of age.

12           **260.20 Cost sharing. (1) NO COST SHARING.** The plan shall cover the following  
13 preventive services without any cost-sharing requirement:

14           (a) Prenatal care for pregnant women.

15           (b) Well-baby care.

16           (c) Medically appropriate examinations and immunizations for children up to  
17 18 years of age.

18           (d) Medically appropriate gynecological exams, Papanicolaou tests, and  
19 mammograms.

20           (e) Medically appropriate regular medical examinations for adults, as  
21 determined by best practices.

22           (f) Medically appropriate colonoscopies.

23           (g) Preventive dental care for children up to 18 years of age.

1 (h) Other preventive services or procedures, as determined by the board, for  
2 which there is scientific evidence that exemption from cost sharing is likely to reduce  
3 health care costs or avoid health risks.

4 (i) Chronic care services, provided that the participant receiving the services  
5 is participating in, and complying with, a chronic disease management program as  
6 defined by the board.

7 **(2) DEDUCTIBLES.** (a) *Maximum amounts and who must pay.* 1. Subject to subd.  
8 2., during any year, a participant who is 18 years of age or older on January 1 of that  
9 year shall pay a deductible of \$300, which shall apply to all covered services and  
10 articles.

11 2. During any year, a family consisting of 2 or more participants who are 18  
12 years of age or older on January 1 of that year shall pay a deductible of \$600, which  
13 shall apply to all covered services and articles.

14 3. During any year, a participant who is under 18 years of age on January 1 of  
15 that year shall not be required to pay a deductible.

16 4. Except for copayments and coinsurance, the plan shall provide a participant  
17 with full coverage for all covered services and articles after the participant has  
18 received covered services and articles totaling the applicable deductible amount  
19 under this paragraph, regardless of whether the participant has paid the deductible  
20 amount.

21 (b) *Provider requirements.* 1. A provider that provides to a participant a  
22 covered service or article to which a deductible applies shall charge for the service  
23 or article the payment rate established by the board under s. 260.30 (7) (b) 1. if the  
24 participant's coverage is under the fee-for-service option under s. 260.30 (2) (a) or  
25 the applicable network rate for the service or article, as determined by the board, if

1 the participant's coverage is under the health care network option under s. 260.30  
2 (2) (b). Except as provided in subd. 3., a provider of a covered service or article to  
3 which a deductible applies shall accept as payment in full for the covered service or  
4 article the payment rate specified in this subdivision and may not bill a participant  
5 who receives the service or article for any amount by which the charge for the service  
6 or article is reduced under this subdivision.

7 2. Except for prescription drugs, a provider may not refuse to provide to a  
8 participant a covered service or article to which a deductible applies on the basis that  
9 the participant does not pay, or has not paid, any applicable deductible amount  
10 before the service or article is provided.

11 3. A provider may not charge any interest, penalty, or late fee on any deductible  
12 amount owed by a participant unless the deductible amount owed is at least 6  
13 months past due and the provider has provided the participant with notice of the  
14 interest, penalty, or late fee at least 90 days before the interest, penalty, or late fee  
15 payment is due. Interest may not exceed 1 percent per month, and any penalty or  
16 late fee may not exceed the provider's reasonable cost of administering the unpaid  
17 bill.

18 (c) *Adjustments by board.* Notwithstanding par. (a) 1. and 2., the board may  
19 adjust the deductible amounts specified in par. (a) 1. and 2., but only to reduce those  
20 amounts.

21 **(3) COPAYMENTS AND COINSURANCE.** (a) *General copayments.* During any year,  
22 a participant who is 18 years of age or older on January 1 of that year shall pay a  
23 copayment of \$20 for medical, hospital, and related health care services, as  
24 determined by the board.

1           (b) *Specialist provider services without referral.* A participant, regardless of  
2 age, who receives health care services from a specialist provider without a referral  
3 from his or her primary care provider under the plan shall be required to pay 25  
4 percent of the cost of the services provided.

5           (c) *Inappropriate emergency room use.* Notwithstanding par. (a), a participant  
6 who is 18 years of age or older shall pay a copayment of \$60 for inappropriate  
7 emergency room use, as determined by the board.

8           (d) *Prescription drugs.* 1. All participants, regardless of age, shall pay \$5 for  
9 each prescription of a generic drug that is on the formulary determined by the board.

10           2. All participants, regardless of age, shall pay \$15 for each prescription of a  
11 brand-name drug that is on the formulary determined by the board.

12           3. All participants, regardless of age, shall pay \$40 for each prescription of a  
13 brand-name drug that is not on the formulary determined by the board.

14           4. Notwithstanding subs. 1. to 3., no participant shall pay more for a  
15 prescription drug than the actual cost of the prescription drug plus the negotiated  
16 dispensing fee.

17           (e) *Adjustments by board.* Notwithstanding pars. (a) to (d), the board may  
18 adjust the copayment and coinsurance amounts specified in pars. (a) to (d).

19           **(4) MAXIMUM AMOUNTS.** Notwithstanding the deductible, coinsurance, and  
20 copayment amounts in subs. (2) and (3), all of the following apply:

21           (a) Subject to par. (b), a participant who is 18 years of age or older on January  
22 1 of a year may not be required to pay more than \$2,000 during that year in total cost  
23 sharing under subs. (2) and (3).

24           (b) A family consisting of 2 or more participants may not be required to pay  
25 more than \$3,000 during a year in total cost sharing under subs. (2) and (3).

1           **260.30 Service areas; selection and payment of health care providers**  
2           **and health care networks. (1)** ESTABLISHMENT OF AREAS WHERE SERVICES WILL BE  
3           PROVIDED. The board may establish areas in the state, which may be counties,  
4           multicounty regions, or other areas, for the purpose of receiving bids from health care  
5           networks. These areas shall be established so as to maximize the level and quality  
6           of competition among health care networks or to increase the number of provider  
7           choices available to eligible persons and participants in the areas.

8           **(2)** OPTIONS AVAILABLE IN EACH AREA. In each area designated by the board under  
9           sub. (1), the board shall offer both of the following options for delivery of health care  
10          services under the plan:

11          (a) An option, known as the “fee-for-service option,” under which participants  
12          must choose a primary care provider, may be referred by the primary care provider  
13          to any medical specialist, and may be admitted by the primary care provider or  
14          specialist to any hospital or other facility, for the purpose of receiving the benefits  
15          provided under this chapter. Under this option, the board, with the assistance of one  
16          or more administrators chosen by a competitive bidding process and with whom the  
17          board has contracted, shall pay directly, at the provider payment rates established  
18          by the board under sub. (7) (b) 1., for all health care services and articles that are  
19          covered under the plan.

20          (b) An option under which one or more health care networks that meet the  
21          qualifying criteria in sub. (4) and are certified under sub. (5) provide health care  
22          services to participants. The board is required to offer this option in each area  
23          designated by the board to the extent that qualifying health care networks exist in  
24          the area.



1           **(3) SOLICITATION OF BIDS FROM HEALTH CARE NETWORKS.** The board shall annually  
2 solicit sealed risk-adjusted premium bids from competing health care networks for  
3 the purpose of offering health care coverage to participants. The board shall request  
4 each bidder to submit information pertaining to whether the bidder is a qualifying  
5 health care network, as described in sub. (4).

6           **(4) QUALIFYING HEALTH CARE NETWORKS.** A health care network is qualifying if  
7 it does all of the following:

8           (a) Demonstrates to the satisfaction of the board that the fixed monthly  
9 risk-adjusted amount that it bids to provide participants with the health care  
10 benefits specified in this chapter reasonably reflects its estimated actual costs for  
11 providing participants with such benefits in light of its underlying efficiency as a  
12 network, and has not been artificially underbid for the predatory purpose of gaining  
13 market share.

14           (b) Will spend at least 92 percent of the revenue it receives under this chapter  
15 on one of the following:

16           1. Payments to health care providers in order to provide the health care benefits  
17 specified in this chapter to participants who choose the health care network.

18           2. Investments that the health care network has reasonably determined will  
19 improve the overall quality or lower the overall cost of patient care.

20           (c) Ensures all of the following:

21           1. That participants living in an area that a health care network serves shall  
22 not be required to drive more than 30 minutes, or, in a metropolitan area served by  
23 mass transit, spend more than 60 minutes using mass transit facilities, in order to  
24 reach the offices of at least 2 primary care providers, as defined by the board.

1           2. That physicians, physician assistants, nurses, clinics, hospitals, and other  
2 health care providers and facilities, including providers and facilities that specialize  
3 in mental health services and alcohol or other drug abuse treatment, are  
4 conveniently available, as defined by the board, to participants living in every part  
5 of the area that the health care network serves.

6           (d) Ensures that participants have access, 24 hours a day, 7 days a week, to a  
7 toll-free hotline and help desk that is staffed by persons who live in the area and who  
8 have been fully trained to communicate the benefits provided under this chapter and  
9 the choices of providers that participants have in using the health care network.

10          (e) Ensures that each participant who chooses the health care network selects  
11 a primary care provider who is responsible for overseeing all of the participant's care.

12          (f) Will provide each participant with medically appropriate and high-quality  
13 health care, including mental health services and alcohol or other drug abuse  
14 treatment, in a highly coordinated manner.

15          (g) Emphasizes, in its policies and operations, the promotion of healthy  
16 lifestyles; preventive care, including early identification of and response to high-risk  
17 individuals and groups, early identification of and response to health disorders,  
18 disease management, including chronic care management, and best practices,  
19 including the appropriate use of primary care, medical specialists, medications, and  
20 hospital emergency rooms; and the utilization of continuous quality improvement  
21 standards and practices that are generally accepted in the medical field.

22          (h) Has developed and is implementing a program, including providing  
23 incentives to providers when appropriate, to promote health care quality, increase  
24 the transparency of health care cost and quality information, ensure the

1 confidentiality of medical information, and advance the appropriate use of  
2 technology.

3 (i) Has entered into shared service agreements with out-of-network medical  
4 specialists, hospitals, and other facilities, including medical centers of excellence in  
5 the state, through which participants can obtain, at no additional expense to  
6 participants beyond the normally required level of cost sharing, the services of  
7 out-of-network providers that the network's primary care physicians selected by  
8 participants have determined is necessary to ensure medically appropriate and  
9 high-quality health care, to facilitate the best outcome, or, without reducing the  
10 quality of care, to lower costs.

11 (j) Has in place a comprehensive, shared, electronic patient records and  
12 treatment tracking system and an electronic provider payment system.

13 (k) Has adopted and implemented a strong policy to safeguard against conflicts  
14 of interest.

15 (L) Has been organized by physicians or other health care providers, a  
16 cooperative, or an entity whose mission includes improving the quality and lowering  
17 the cost of health care, including the avoidance of unnecessary operating and capital  
18 costs arising from inappropriate utilization or inefficient delivery of health care  
19 services, unwarranted duplication of services and infrastructure, or creation of  
20 excess capacity.

21 (m) Agrees to enroll and provide the benefits specified in this chapter to all  
22 participants who choose the network, regardless of the participant's age, sex, race,  
23 religion, national origin, sexual orientation, health status, marital status, disability  
24 status, or employment status, except that a health care network may do one of the  
25 following:

1           1. Limit the number of new enrollees it accepts if the health care network  
2 certifies to the board that accepting more than a specified number of enrollees would  
3 make it impossible to provide all enrollees with the benefits specified in this chapter  
4 at the level of quality that the network is committed to maintaining, provided that  
5 the health care network uses a random method for deciding which new enrollees it  
6 accepts.

7           2. Limit the participants that it serves to a specific affinity group, such as  
8 farmers or teachers, that the health care network has certified to the board, provided  
9 that the limitation does not involve discrimination based on any of the factors  
10 described in this paragraph and has neither been created for the purpose, nor will  
11 have the effect, of screening out higher-risk enrollees. This subdivision applies only  
12 to affinity groups that are in existence as of December 31, 2007.

13           **(5) CERTIFICATION OF HEALTH CARE NETWORKS AND CLASSIFICATION OF BIDS.** (a) The  
14 board shall review the bids submitted under sub. (3), the information submitted by  
15 bidders pertaining to whether the bidders are qualifying health care networks, and  
16 other evidence provided to the board as to whether a particular bidder is a qualifying  
17 health care network.

18           (b) Based on the information about bidder qualification submitted or otherwise  
19 provided under par. (a), the board shall certify which health care networks are  
20 qualifying health care networks.

21           (c) With respect to all health care networks that the board certifies under par.  
22 (b), the board shall open the submitted, sealed bids at a predetermined time. The  
23 board shall classify the certified health care networks according to price and quality  
24 measures after comparing their risk-adjusted per-month bids and assessing their  
25 quality. The board shall classify the network that bid the lowest price as the

1 lowest-cost network, and shall classify as a low-cost network any network that has  
2 bid a price that is close to the price bid by the lowest-cost network. Any other  
3 network shall be classified as a higher-cost network.

4 **(6) OPEN ENROLLMENT.** The board shall provide an annual open enrollment  
5 period during which each participant may select a certified health care network from  
6 among those offered, or a fee-for-service option. Coverage shall be effective on the  
7 following January 1. A participant who does not select a certified health care  
8 network or the fee-for-service option will be assigned randomly to one of the  
9 networks that have been classified under sub. (5) as having submitted the lowest or  
10 a low bid and as performing well on quality measures, or to the fee-for-service option  
11 if that is the lowest-cost option. A participant who selects the fee-for-service option  
12 or a certified health care network that has been classified as a higher-cost network,  
13 but who fails to pay the additional payment under sub. (7) (a) 2., shall be assigned  
14 randomly to one of the networks that has been classified under sub. (5) as the  
15 lowest-cost network or as a low-cost network and as performing well on quality  
16 measures, or to the fee-for-service option if that is the lowest-cost option.

17 **(7) PAYMENTS TO NETWORKS AND PROVIDERS.** (a) *Payments to health care*  
18 *networks.* 1. On behalf of each participant who selects or has been assigned to a  
19 certified health care network that has been classified under sub. (5) (c) as the  
20 lowest-cost network or a low-cost network and as performing well on quality  
21 measures, the board shall pay monthly to the health care network the full  
22 risk-adjusted per-member per-month amount that was bid by the network. The  
23 dollar amount shall be actuarially adjusted for the participant based on age, sex, and  
24 other appropriate risk factors determined by the board. A participant who selects

1 or is assigned to the lowest-cost network or a low-cost network shall not be required  
2 to pay any additional amount to the network.

3 2. If a participant chooses instead to enroll in a certified health care network  
4 that has been classified under sub. (5) (c) as a higher-cost network, the board shall  
5 pay monthly to the chosen health care network an amount equal to the bid submitted  
6 by the network that the board classified under sub. (5) (c) as the lowest-cost network  
7 and as having performed well on quality measures. The dollar amount shall be  
8 actuarially adjusted for the participant based on age, sex, and other appropriate risk  
9 factors determined by the board. A participant who chooses to enroll in a higher-cost  
10 network shall be required to pay monthly, in addition to the amount paid by the  
11 board, an additional payment sufficient to ensure that the chosen network receives  
12 the full price bid by that network.

13 3. The board may retain a percentage of the dollar amounts established for each  
14 participant under subds. 1. and 2. to pay to certified health care networks that have  
15 incurred disproportionate risk not fully compensated for by the actuarial adjustment  
16 in the amount established for each eligible person. Any payment to a certified health  
17 care network under this subdivision shall reflect the disproportionate risk incurred  
18 by the health care network.

19 (b) *Payments to fee-for-service providers.* 1. The board shall establish provider  
20 payment rates that will be paid to providers of covered services and articles that are  
21 provided to participants who choose the fee-for-service option under sub. (2) (a). The  
22 payment rates shall be fair and adequate to ensure that this state is able to retain  
23 the highest quality of medical practitioners. The board shall limit increases in the  
24 provider payment rate for each service or article such that any increase in per person  
25 spending under the plan does not exceed the national rate of medical inflation.

1           2. Except for deductibles, copayments, coinsurance, and any other cost sharing  
2 required or authorized under the plan, a provider of a covered service or article shall  
3 accept as payment in full for the covered service or article the payment rate  
4 determined under subd. 1. and may not bill a participant who receives the service or  
5 article for any amount by which the charge for the service or article is reduced under  
6 subd. 1.

7           3. The board, with the assistance of its actuarial consultants, shall establish  
8 the monthly risk-adjusted cost of the fee-for-service option offered to participants  
9 under sub. (2) (a). The board shall classify the fee-for-service option in the same  
10 manner that the board classifies certified health care networks under sub. (5) (c).

11           4. If the board has determined under sub. (5) (c) that there is at least one  
12 certified low-cost health care network in an area, which may be the lowest-cost  
13 health care network, and if the fee-for-service option offered in that area has been  
14 classified as a higher-cost choice under subd. 3., the cost to a participant enrolling  
15 in the fee-for-service option shall be determined as follows:

16           a. If there are available to the participant 3 or more certified health care  
17 networks classified under sub. (5) (c) as low-cost networks, or as the lowest-cost  
18 network and 2 or more low-cost networks, the participant shall pay the difference  
19 between the cost of the lowest-cost health care network and the monthly  
20 risk-adjusted cost established under subd. 3. for the fee-for-service option, except  
21 that the amount paid may not exceed \$100 per month for an individual, or \$200 per  
22 month for a family, as adjusted for medical inflation.

23           b. If there are available to the participant 2 certified health care networks  
24 classified under sub. (5) (c) as low-cost networks, or as the lowest-cost network and  
25 one low-cost network, the participant shall pay the difference between the cost of the

1 lowest-cost health care network and the monthly risk-adjusted cost established  
2 under subd. 3. for the fee-for-service option, except that the amount paid may not  
3 exceed \$65 per month for an individual, or \$125 per month for a family, as adjusted  
4 for medical inflation.

5 c. If there is available to the participant only one certified health care network  
6 classified under sub. (5) (c) as a low-cost network, or as the lowest-cost network, the  
7 person shall pay the difference between the cost of the lowest-cost health care  
8 network and the monthly risk-adjusted cost established under subd. 3. for the  
9 fee-for-service option, except that the amount paid may not exceed \$25 per month  
10 for an individual, and \$50 per month for a family, as adjusted for medical inflation.

11 6. If the board has determined, under sub. (5) (c), that there is no certified  
12 lowest-cost health care network or low-cost health care network in the area, there  
13 shall be no extra cost to the participant enrolling in the fee-for-service option.

14 **(8) INCENTIVE PAYMENTS TO FEE-FOR-SERVICE PROVIDERS.** Health care providers  
15 and facilities providing services under the fee-for-service option under sub. (2) (a)  
16 shall be encouraged to collaborate with each other through financial incentives  
17 established by the board. Providers shall work with facilities to pool infrastructure  
18 and resources; to implement the use of best practices and quality measures; and to  
19 establish organized processes that will result in high-quality, low-cost medical care.  
20 The board shall establish an incentive payment system to providers and facilities

15 (h) “Self–employed individual” means an individual who is required under the  
16 Internal Revenue Code to file schedule SE.

17 (i) “Social security wages” means:

18 1. For purposes of sub. (2) (a), the amount of wages, as defined in section 3121  
19 (a) of the Internal Revenue Code, paid to an employee by an employer in a taxable  
20 year, up to a maximum amount that is equal to the social security wage base.

21 2. For purposes of sub. (2) (b), the amount of net earnings from  
22 self–employment, as defined in section 1402 (a) of the Internal Revenue Code,  
23 received by an individual in a taxable year, up to a maximum amount that is equal  
24 to the social security wage base.

1           3. For purposes of sub. (3), the amount of wages, as defined in section 3121 (a)  
2 of the Internal Revenue Code, paid by an employer in a taxable year with respect to  
3 employment, as defined in section 3121 (b) of the Internal Revenue Code, up to a  
4 maximum amount that is equal to the social security wage base multiplied by the  
5 number of the employer's employees.

2 making the need for comprehensive reform urgent. Rising costs are seriously  
3 threatening the ability of Wisconsin businesses to globally compete; farms to thrive;  
4 government to provide needed services; schools to educate; and local citizens to form  
5 new and successful business ventures. Some indicators of rising costs are the  
6 following:

7           a. Total health care spending in Wisconsin in 2007 is projected to be \$42.3  
8 billion, and is projected to grow 82 percent, to \$76.9 billion, in the next decade.

9           b. The cost of employer–provided health care in Wisconsin increased by 9.3  
10 percent in 2006, averaging \$9,516 per employee. This figure is 26 percent more than  
11 the national average.

12           c. Employee premium contributions and out–of–pocket costs are rising faster  
13 than wages.

14           d. Rising costs have led to a decline in employer–provided health benefits. In  
15 1979, 73 percent of private–sector Wisconsin workers had employer–based health  
16 insurance coverage; however, only 57 percent received health benefits in 2004.

17           e. At least one–half of all personal bankruptcies in the United States are the  
18 result of medical expenses. Over 75.7 percent of this group had insurance at the  
19 onset of illness. In 2004, there were 13,454 medical bankruptcies in Wisconsin  
20 affecting 37,360 people.

21           f. The costs of health services provided to individuals who are unable to pay are  
22 shifted to others. Of the \$22 billion charged by hospitals in 2005, \$736,000,000 was  
23 not collected. Those who bear the burden of this cost shift have an increasingly  
24 difficult time paying their own health care costs.

1           2. ‘Access.’ There is a large and increasing number of people who have no health  
2 insurance or who are underinsured. For this growing population, health care is  
3 unaffordable and, most often, not received in the most timely and effective manner.

4 Some indicators of lack of access to health care are as follows:

5           a. Over one 500,000 Wisconsin residents were uninsured at any given point  
6 during 2007.

7           b. Over 65 percent of the uninsured in Wisconsin are employed.

8           c. The uninsured are less likely to seek care and, thus, have poorer health  
9 outcomes compared to the insured population.

10           d. In 2007, total spending on the uninsured in Wisconsin is projected to reach  
11 over \$1,000,000,000. About 23.2 percent of this amount will be in the form of  
12 uncompensated care; 21.7 percent will be provided through public programs; and  
13 37.5 percent will be paid by the uninsured individuals.

14           3. ‘Inequity.’ The health care system contains inequities. Some indicators of  
15 inequity are as follows:

16           a. Wisconsin businesses are competing on an uneven playing field. The  
17 majority of Wisconsin businesses that do insure their workers are subsidizing those  
18 businesses that are not paying their fair share for health care.

19           b. Our current system forces the sick and the aging to pay far higher premiums  
20 than the healthy and those covered under group plans, rather than spreading the  
21 risk across the broadest pool possible.

22           c. The uninsured face medical charges by hospitals, doctors, and other health  
23 care providers that are 2.5 times what public and private health insurers pay.

24           4. ‘Inefficiency.’ Wisconsin does not have a clearly defined, integrated health  
25 care system. Our health care system is complex, fragmented, and disease-focused

1 rather than health-focused, resulting in massive inefficiencies and placing  
2 inordinate administrative burdens on health care professionals. Some indicators of  
3 inefficiency are as follows:

4 a. Health care financing is accomplished through a patchwork of public  
5 programs, private sector employer-sponsored self-insurance, commercial  
6 insurance, and individual payers. The most recent study for Wisconsin estimates  
7 that about 27 cents of every health care dollar is spent on marketing, overhead, and  
8 administration, leaving only 73 cents left to deliver medical care.

9 b. This fragmentation and misaligned financial incentives lead, in some  
10 instances, to excessive or inadequate care and create barriers to coordination and  
11 accountability among health care professionals, payers, and patients.

12 c. The Institute of Medicine estimates that between 30 cents and 40 cents of  
13 every health care dollar is spent on costs of poor quality — overuse, underuse,  
14 misuse, duplication, system failures, unnecessary repetition, poor communication,  
15 and inefficiency. Included in this inefficiency are an unacceptable number of adverse  
16 events attributable to medical errors. Patients receive appropriate care based on  
17 known “best practices” only about one-half of the time.

18 d. The best care results from the conscientious, explicit, and judicious use of  
19 current best evidence and knowledge of patient values by well-trained, experienced  
20 clinicians.

21 5. ‘Limitations on reform.’ Federal laws and programs, such as Medicaid,  
22 Medicare, Tri-Care, and Champus, constrain Wisconsin’s ability to establish  
23 immediately a fully integrated health care system.

24 6. ‘Wisconsin as a laboratory for the nation.’ Wisconsin is in a unique position  
25 to successfully implement major health care reform. Many providers are already

1 organized into comprehensive delivery systems and have launched innovative pilot  
2 programs to improve both the quality and efficiency of their care. Wisconsin is at the  
3 forefront in developing systems for health information transparency. Organizations  
4 such as the Wisconsin Collaborative for Healthcare Quality, Wisconsin Health  
5 Information Organization, and the Wisconsin Hospital Association have launched  
6 ambitious projects to provide data on quality, safety, and pricing.

1 the initial members may be provisionally appointed by the governor, subject to  
2 confirmation by the senate. Any such appointment shall be in full force until acted  
3 upon by the senate, and when confirmed by the senate shall continue for the  
4 remainder of the term, or until a successor is chosen and qualifies. A provisional  
5 appointee may exercise all of the powers and duties of the office to which such person  
6 is appointed during the time in which the appointee qualifies. Any appointment  
7 made under this subsection that is withdrawn or rejected by the senate shall lapse.  
8 When a provisional appointment lapses, a vacancy occurs. Whenever a new  
9 legislature is organized, any appointments then pending before the senate shall be  
10 referred by the president to the appropriate standing committee of the newly  
11 organized senate.

12 (d) *Property tax credit.* If with respect to levies imposed for 2009, any taxing  
13 jurisdiction, as defined in section 74.01 (7) of the statutes, reduces the costs of  
14 providing health care coverage to its employees as a result of providing that coverage
