Robin: As a follow up to the drafting instructions I just sent you, there's a couple things going on, and you may already be aware of them but I'll mention them anyway. First, with respect to the well woman program, there is already a GPR appropriation for that program, 20.435(5)(cb), so I think the amendment request would simply require an increase in that existing GPR appropriation by \$62,500 GPR annually. Second, with respect to the colposcopy portion of this, we will still need the new statutory language you drafted earlier, but the funding will now come from a new GPR appropriation rather than a SEG appropriation from the Health Care Quality Fund. Third, we will have to adjust upward the amount of SEG from the Health Care Quality Fund for Tobacco Use Control Grants. As of right now, that funding is \$19,837,500 in 2007-08 and \$19,862,500 in 2008-09. The effect of this amendment would be to increase the SEG funding for Tobacco Use Control Grants from the Health Care Quality Fund to \$20,000,000 in 2007-08 and \$20,000,000 in 2008-09.

4 purpose of providing reimbursement for breast cancer and cervical cancer screenings  
5 under the Well-Woman Program.

6 **2.** Page 197, line 15: after that line insert:

7 "(dg) Clinic aids GPR B \$100,000 \$75,000".

8 **3.** Page 199, line 5: increase the dollar amount for fiscal year 2007-08 by

9 \$162,500 and in(de)crease the dollar amount for fiscal year 2008-09 by \$137,500 for  
10 the purpose for which the appropriation is made.
