10 following conditions are satisfied:

11 (a) The fish are legally taken.

12 (b) While the fish are at the restaurant and before the fish are prepared for
13 eating, they are stored in a cooler, which may be a portable cooler, that does not
14 contain any other food.

15 (c) The area where the fish are prepared for eating is washed and sanitized
16 before and after preparation of the fish.

17 (d) All items used to prepare and serve the fish are washed in a dishwasher
18 after such use.

19 (2) A restaurant or temporary restaurant may make a pecuniary profit from
20 preparing and serving fish as provided under sub. (1). " ✓
