Pam, I will call you in a minute. So sorry for the delay. Revised list below.

Change to 260.20(2) cost-sharing (not in statutory language):

- 1) A deductible of \$300/individual and \$600/family but NO deductible for children under 19.
- 2) When enrollee is pre-deductible, enrollee should be charged the amounts for prescriptions and services that have been negotiated by the Healthy Wisconsin Trust
- 3) Full coverage kicks in after \$300 (\$600) of services have been received, regardless of whether all services have been paid for.
- 4) A provider may not deny care to any enrollee based on their failure to pay any pre-deductible amounts prior to service
- 5) Providers may not charge any interest or penalties on balance-billed amounts unless more than 6 months has passed and enrollee has received 90 days written notice on what the interest and late fee will be.
- 6) Under no circumstances can interest exceed 1%/month nor can late fees exceed the reasonable cost of administering the unpaid bill.
- 7) The Healthy Wisconsin Trust has the discretion to adjust the deductible if it appears to be deterring necessary medical services but may not exceed the maximum of \$300/individual and \$600/family.
