Require DOT to award a grant of \$500,000 in the 2007-09 biennium to the Town of Pound in Marinette County from the SEG appropriation for the transportation economic assistance (TEA) program for the extension of North 19th Road to West 16th Road. Modify the statutory authority for the TEA program to allow this grant to be made and specify that the grant shall be made notwithstanding program eligibility criteria or local match requirements.
