

The supplemental title fee transfer/supplemental debt service appropriation is mostly good, except that I forgot to account for the interactive effect on the numbers that Chris Pollek's draft has on this. Instead of \$12,763,000 on page 1, line 5, the number should be \$13,623,000.

There's no need to combine the quarterly payments draft with this one, but, as I'm sure you're aware, some things will need to be reconciled. The quarterly payments take effect immediately, so it will apply to both 4(r) and 4(f).

Also, items 12., 13., and 14. in LRB b0511/1 are included in LRB b0350/1 as items 51., 52., and 53. Items 51., 52., and 53. should be removed from LRB b0511/1.
