1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 193, line 18: increase the dollar amount for fiscal year 2007-08 by
3 \$2,222,400 and increase the dollar amount for fiscal year 2008-09 by \$2,203,400 to
4 decrease the copayment for generic prescription drugs under the program of
5 prescription drug assistance for elderly persons.

#, P. 763, line 25: after that line insert:

6 **SECTION 22.** 49.688 (3) (c) 1. of the statutes is amended to read:

7 49.688 (3) (c) 1. A copayment of \$5 ~~\$3~~ for each prescription drug that bears only
8 a generic name.
