Subject: Drafting Instructions re: Assembly Republicans

Hi Pam: This morning we are shifting gears to the assembly republicans and their changes to the JFC budget bill. Charlie Morgan has just sent to Debora Kennedy a list of the items for which we will need drafts, and we've been asked to go through the items we have responsibility for and provide specific drafting instructions to the drafting attorneys.

I have several items, and I'm not certain you are the LRB drafting attorney, but I thought I'd start with you because they relate to insurance and OCI. Please let me know if I should direct these to somebody else in your shop. The first deals with the Injured Patients and Families Compensation Fund. The Assembly Republicans want to do three things with respect to the IPFCF:

- a) Delete the transfer of \$175 million out of the Fund. I think the only drafting related to this may relate to some non-statutory session law language in s. 9225(2);
- b) With respect to the IPFCF itself, insert statutory language in Chapter 655 that would prohibit the Governor from introducing a budget that uses funds from the IPFCF for purposes not specifically authorized in the statutes pertaining to the IPFCF; and
- c) Amend s. 655.002(1)(e) to delete the words "organized and" from that section of the statutes. The intent is to allow out-of-state corporation to participate in the fund even if they are not organized in WI.

I hope this is clear. Please give me a call if you have any questions about these items. I will have a few more insurance items for you shortly!
