The registry that the provision is referring to is referenced in DHFS administrative rule 129.10.

The intent is to:

Direct DHFS to modify the registry that the Department maintains of persons who have satisfactorily completed a nurse's assistant, home health aide or hospice aide instructional program and competency evaluation program or only a competency evaluation program to indicate when individuals on the registry are under investigation for charges relating to the abuse or neglect of a patient, indicating that the outcome of an investigation is pending.
