Hi Pam:

I still don't have the final word on child care and child support, but I have a piece of child care that I can pass on.

Just as W-2 has a 60 month time limit, make the receipt of child care subsidies limited to 60 months. The age of the child does not matter—it's just that a family cannot receive child care subsidies for more than 5 years (cumulative—does not have to be consecutive years). This would grandfather in anyone who is currently receiving subsidies. No fiscal effect—because no one would be cut off until five years after the effective date.

So, if the parent has 3 children, the parent can receive 5 years worth of subsidies for each child. Perhaps inserting "for each of the individual's eligible children" after "does not exceed 60 months" or something like that? Sorry about that. Let me know if you have any questions.
