- ✓ We should go with the Senate allocation for 49.175(1)(a) Wisconsin Works benefits.
- ✓ The Senate increased the Joint Finance Allocation by \$321,800 in FY 2007-08 and by \$643,700 in FY 2008-09.
- ✓ This would also necessitate reinstating the language in the Senate version that gave Wisconsin Works benefits to Mothers in the third trimester of an at-risk birth.




