Hi Diane and Joe---

The A. Nat. Res. Committee will be taking a vote on AB 228 next Wednesday and I need to get the amendment in final draft form by at least next Tuesday. Here is what I plan to take to Mary Gibson-Glass, the LRB drafter. Please let me know if there are still problems with this.

Page 3, line 24----strike "the August 1st" and substitute "15 days".

Page 4, line 21---after that line insert:

"SECTION 14. 29.569 (3) (c) of the statutes is created to read:

29.569 (3) (c) Restrictions on transfer of a sturgeon spearing license. The department may only transfer a sturgeon spearing license under s. 29.179 (2) commencing on November 1 and ending no later than 15 days preceding the ~~last~~ **first** day of the open season for the spearing of lake sturgeon that follows that November 1."

As I understand it, this amendment will prevent the transfer of a sturgeon spearing license before November 1, and will allow the transfer to occur from Nov. 1 up until the 15th day prior to the ~~end~~ **beginning** of the open season for sturgeon spearing. As a result, a person who obtains and transfers a sturgeon spearing license to a minor after Nov. 1, as allowed in the amendment, will not be able to obtain a Lake Winnebago spearing license, because those licenses are not issued after October 31.

Here's a question---on page 3 line 24 of the bill, the application to transfer any of the approvals must be made (as amended) prior to the 15th day before the end of the applicable open season. However, the bill doesn't say when DNR must issue the approval to the transferee. Presumably an application for a sturgeon spearing license can be made at any time prior to the 15th day prior to the ~~end~~ **beginning** of the season, and DNR would hold the application and not issue the license to the minor until Nov. 1. My question is whether the end date in the amendment for issuing the license to the minor should be the 15th day prior to the end of the season, or should be the last day of the season? It is the beginning of the season (see below)

**Presumably an application for a sturgeon spearing license can be made at any time prior to the 15th day immediately preceding the beginning of the open season. DNR would be authorized to transfer applications to minors anytime between November 1 and 15 days prior to the open season. The only reason we have asked for 15 days prior -- is to provide adequate processing time to ensure that customers get collect fees, verify eligibility, and issue approvals prior to the season opener.**

Please check my draft language, and my explanatory paragraph, and thanks much for the help.
