John,

I see two ways to accomplish this. One would be to create a new provision that essentially creates a new plate for surviving family members of firefighters. Another method would be to amend s. 341.14 (6r) (g) to allow the family to retain and renew existing plates upon the firefighter's death (even if registration is transferred to surviving family member). Do you have a preference? If not, can I contact DOT about the request to see if they have a preference? (One method might be more expensive or difficult for DOT to administer than the other.) Thanks. Recently, Green Bay lost Lt. Arnie Wolff, a 17 year veteran of the Green Bay Fire Department who was killed in the line of duty while battling a house fire. Lt. Wolff left behind a wife and three children.

Unfortunately, Lt. Wolff's spouse is unable to keep the personalized (WOLFF) firefighter license plate because of her husband's death.

We would like to introduce legislation next session that would extend eligibility for this type of license plate to spouse's or immediate family members of firefighters who die in the line of duty. If you have any questions, please contact me.
