

Hi Aaron,

After discussing the SB 20 amendment with Carson Frazier at DOT, Jason in Rep. Petrowski's office has decided to try to include surviving spouses of firefighters who die in the line of duty in the same special group as regular firefighters, instead of creating a separate special group that has an identical plate. This is generally because of DOT's concerns about the cost of programming a new special group. Can you see if you can come up with a way to reconcile the cross-reference issues and other conflicting provisions created by taking this approach?

Also, he has decided to eliminate the provision in the amendment authorizing DOT to ask a person to which the decedent's plate number was subsequently issued to relinquish the number. Instead, he would like DOT to re-issue the plate if the request is made within 2 years of relinquishment of the plate (it is apparently current practice for DOT not to make a relinquished number available to others for 2 years). If the request is not made within this time, the request would be treated as a new request for a special group plate, and the requester would have to choose from numbers available at that time.

This bill has been pulled off the calendar for tomorrow's executive session so that these changes can be explored.
