TO 2007 SENATE BILL 409**

February 28, 2008 – Offered by COMMITTEE ON HEALTH, HUMAN SERVICES, INSURANCE,  
AND JOB CREATION.

1 **AN ACT** *to amend* 450.06 (1); and *to create* 450.062 of the statutes; **relating to:**  
2 remote dispensing by pharmacists and granting rule-making authority.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 **SECTION 1.** 450.06 (1) of the statutes is amended to read:

4 450.06 (1) ~~No~~ Except as provided in s. 450.062, no pharmacist may dispense  
5 at any location in this state that is not licensed as a pharmacy by the board. No  
6 person in this state may use or display the title “pharmacy,” “drugstore,”  
7 “apothecary,” or any other title, symbol, or insignia having the same or similar  
8 meanings, except for a place of practice which is licensed under this section as a  
9 pharmacy by the board.

10 **SECTION 2.** 450.062 of the statutes is created to read:

11 **450.062 Remote dispensing.** Pursuant to rules promulgated by the board,  
12 a pharmacist may dispense at the following locations:
