Hi, Cathlene –

I was not sure whether Debora Kennedy was in today – I left a voice mail message with her, but wanted to get this drafting request in as soon as possible for the budget adjustment bill.

I'd like a draft, an amendment to LRB 378/p1, that would reduce funding for medical assistance benefits under s. 20.435(4)(b) by \$10,000,000 GPR in 2008-09. The draft should not identify a specific purpose or reason for the decrease. We are checking with the administration to determine whether there are any reasons we should state in our summary relating to this provision.

In addition, our team will have two other drafts, that Eric Peck is calling in and will cc you on –

- (1) increasing the tobacco use control grant funding under s. 20.435(4)(fm) by \$250,000 GPR in 2008-09 (a new draft – as an amendment to LRB 378/p1): and *no specific purpose*
- (2) incorporating a provision relating to training for the sale of long-term care insurance (LRB 4313/p1) into the budget adjustment bill (redrafted as an amendment to LRB 378/p1).

In total, our team will need three drafts to 378/p1 to reflect the budget agreement.
