**Assumptions Used in Arriving at Fiscal Estimate**

Current law requires that a victim of a crime or the victim's family, if the victim was killed, be notified when the person who committed the crime is released from a correctional facility, released from extended supervision or parole, or conditionally or permanently released from a mental health facility.

Under this bill, if the victim was a law enforcement officer and was killed, the law enforcement agency that employed the victim and the head of the bargaining unit that represented the victim must also be notified when the person who committed the crime is released.

The Department of Health and Family Services currently notifies victims when a person is released from its mental health facilities or extended supervision. DHFS is able to update its data base to meet the requirements of this bill and absorb the costs associated with the update.
