Senate Bill 40. Relating to: public financing of campaigns for the office of justice of the supreme court, making appropriations, and providing penalties. (FE) By Senators Kreitlow, Taylor, Sullivan, Miller, Risser, Erpenbach, Wirch, Lassa, Lehman, Hansen, Vinehout, and Schultz; cosponsored by Representatives Hintz, Hilgenberg, Smith, Garthwaite, Benedict, Roys, Hebl, Staskunas, Turner, Parisi, Cullen, Jorgensen, Richards, Zepnick, Pocan, Pope-Roberts, Clark, Shilling, Hubler, Black, Berceau, Grigsby, Molepske Jr., and Kessler. **(Report approved by the Governor with partial veto on 12-1-2009. 2009 Wisconsin Act 89)**

Senate Bill 409. Relating to: a postsecondary education tax credit for businesses; increasing annual limits on angel investment tax credits; awarding grants to the WiSys Technology Foundation, Inc.; business plan competitions and an emerging technology center in the University of Wisconsin System; rural outsourcing grants; requiring the Department of Commerce to award grants to a high-technology business development corporation and grants for converting manufacturing facilities; increasing funding for certain economic development programs; a pilot program providing microloans for the creation of new businesses; increasing funding for certain technical college training program grants; providing an exemption from emergency rule procedures; granting rule-making authority; and making appropriations. Senate Bill 530. Relating to: regulating consumer small loans, limiting the areas in which a payday lender may operate, granting rule-making authority, and providing a penalty. (FE) By Senators Sullivan, Hansen, Miller, Lehman, and Robson; cosponsored by

Representative Fields. **(Report approved by the Governor with partial veto on 5-18-2010. 2009 Wisconsin Act 405)**

Senate Bill 434. Relating to: the sale of unpasteurized milk, buttermilk, butter, and cream. (FE) By Senators Kreitlow, Grothman, Taylor, Holperin, Darling, Kapanke, Leibham, and Schultz; cosponsored by Representatives Danou, Hilgenberg, Milroy, Gunderson, Ballweg, Richards, Pope-Roberts, Berceau, Vos, Kerkman, LeMahieu, Roys, Soletski, Sherman, Pridemore, and Newcomer. **(Report vetoed by the Governor on 5-19-2010)**

Senate Bill 616. Relating to: energy conservation standards for the construction of certain buildings, energy and environmental design standards for state buildings, structures, and facilities, energy and environmental design standards for school district facilities and other local government buildings, leasing of state buildings, structures, and facilities, standards for the construction and use of graywater systems, granting rule-making authority, and making an appropriation. (FE) By Senators Risser and Schultz; cosponsored by Representatives Molepske Jr., Mason, Pasch, Roys, Pope-Roberts, Milroy, Sinicki, and Berceau. **(Report vetoed by the Governor on 5-19-2010)**
