SUBJECT: Technical Memorandum on AB 270 Regarding Utility Aid Payments to Towns and Counties for Production Plants that Generate Electricity from Wind Power

The Department of Revenue (DOR) has the following concerns regarding the bill.

The bill provides that the law change is effective for payments in 2009. Estimates of payments for 2009, which were used to prepare 2009 budgets, were mailed to municipalities and counties on or about September 15, 2008. Changes to the shared revenue payment for 2009 would provide a windfall for the towns whose payments would increase and lead to unexpected revenue shortfalls for the counties whose payments would decrease.

We recommend that the change be effective for payments in 2010.
