5 "SECTION 1m. 25.40 (1) (a) 29. of the statutes is created to read:

6 25.40 (1) (a) 29. Moneys received under s. 341.14 (6r) (b) 14. that are deposited
7 into the general fund and credited to the appropriation account under s. 20.395 (5)
8 (eh).".

9 4. Page 4, line 2: after "be" insert "deposited into the general fund and".
