2 **1.** Page 3, line 22: delete "claimant" and substitute "individual described
3 under par. (b)".

4 **2.** Page 4, line 9: after that line insert:

5 "3m. A claimant may not claim the credit under par. (b) for any tuition amounts
6 that the claimant paid or incurred for an individual who is not a resident of this
7 state."

8 **3.** Page 6, line 21: delete "claimant" and substitute "individual described
9 under par. (b)".

10 **4.** Page 7, line 6: after that line insert:

11 "3m. A claimant may not claim the credit under par. (b) for any tuition amounts
12 that the claimant paid or incurred for an individual who is not a resident of this
13 state."
