INSERT ANALYSIS

This bill requires that, beginning on May 1, 2011, ⁹ 2 members of the board must be persons selected from a list of ⁹ 9 names submitted by the Wisconsin Bowhunters Association, the Wisconsin Bear Hunters' Association, Inc., and the Safari Club International, Dairyland Chapters of Wisconsin (designated organizations). Beginning on May 1, 2013, ³ 3 members of the board must be selected from such a list. The list must contain ³ 3 names submitted by each of these organizations. The bill also provides that, when the governor is required to select a member from the list, the governor may ask that the designated organizations to submit a second list from which to select a member. If the governor requests a second list, the governor must make a selection from the names on that second list.
