1 **Relating to:** the life and public service of Russell A. Olson. ✓

2 Whereas, Russell A. Olson ✓ was born on ✓ February 19, 1924, in Chicago, Illinois, ✓
3 and died on April 14, 2010, ✓ in Holmes Beach, Florida; ✓ and

4 Whereas, he ✓ was educated in the Chicago public schools and attended the
5 University of Illinois for ^{*two*} 2 years; and ✓

6 Whereas, Mr. Olson ✓ served in the U.S. Marine Corps from 1942 to 1946 in the
7 Pacific; and

8 Whereas, Mr. Olson ✓ was first elected to the Wisconsin Assembly in 1960,
9 serving in the 1961 ^{*to*} through 1963 sessions, 1967 ^{*to*} through 1969 sessions, and 1973
10 ^{*to*} through 1977 sessions; and ✓

11 Whereas, Russell A. Olson was elected lieutenant governor ✓ with the late
12 Governor ✓ Lee Sherman Dreyfus in November 1978, ✓ and was the last lieutenant ^{*ee*}
13 governor to serve as presiding officer of the Wisconsin senate; ✓ and

1 Whereas, Mr. Olson[✓] chose retirement from public office over running for
 2 re^gselection or for governor after ^{g Governor} Govenor Lee Sherman Dreyfus[✓] announced he would
 3 not seek a second term[✓] in 1982; and

4 Whereas, after retiring, Mr. Olson served eight[✓] years in the[✓] Reagan
 5 administration as Midwest Director of the U.S. Department of Transportation; now,
 6 therefore^{to be} it


