Background:

The Building Inspector Review Board was created by 2005 WI Act 457. It did not provide resources for the administration of the Board. It created a duplicative process for the resolution of complaints regarding building inspectors, and orders of the Department and municipalities. It confuses the roles and processes regarding complaints about orders of the Department and municipalities, and regarding inspectors. The Board has not yet met or conducted any business.
