- Delete MCPC mandatory hours of instruction change
- MCPC staff credentials
- Charter school per pupil adjustment
- Medical Assistance funding reductions
- Delete repeal of QEO
- Delete changes in contributory negligence
- Delete collective bargaining rights for UW faculty/academic staff
- Delete collection of traffic stop data
- Delete prevailing wage changes
- Exempt vacant industrial sites from prevailing wage

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 721, line 21: delete “There is created the” and substitute “The”.[✓]

3 **2.** Page 721, line 22: delete “entity. This” and substitute “entity, is created if
4 the governing body of Milwaukee County adopts a resolution authorizing the
5 creation of the authority and this resolution is ratified by the electors at a
6 referendum held in Milwaukee County. Once created, this”.[✓]

7 **3.** Page 723, line 12: delete “The board” and substitute “If an authority is
8 created under sub. (2) (a), the board”.[✓]

9 **4.** Page 723, line 12: delete “created under sub. (2) (a)”.[✓]

10 **5.** Page 728, line 10: delete “the authority created under sub. (2) (a)” and
11 substitute “if an authority is created under sub. (2) (a), the authority”.[✓]
