





9       301.26 (4) (dm) The department shall set the per person cost assessments to  
10       counties under par. (d) 2. and 3. for care in a Type 1 <sup>juvenile</sup> ~~secured~~ <sup>daily</sup> correctional facility, as  
11       defined in s. 938.02 (19),<sup>↓</sup> and for care for juveniles transferred from a juvenile  
12       correctional institution under s. 51.35 (3).<sup>↓</sup> In setting those assessments, the  
13       department may set one assessment for short-term placements of 30 days or less and  
14       another assessment for long-term placements of more than 30 days. The  
15       department shall set those assessments at least annually, effective on July 1 of each  
16       year, and may adjust those assessments more frequently as necessary to reflect the  
17       average per person daily cost of providing that care. The department shall publish  
18       those assessments and any adjustments to those assessments in the Wisconsin  
19       Administrative Register and is not required to promulgate those assessments or  
20       adjustments as rules under ch. 227. If the department increases an assessment  
21       under this paragraph,<sup>↓</sup> the department shall increase the funds allocated<sup>↓</sup> to counties  
22       under sub. (3) (c) in proportion to each county’s proportional use of those services.”<sup>↓</sup>
