Statement of Amendment Intent: *Provide a short description summarizing the intent of your amendment.* Increase funding to the Milwaukee Area Workforce Investment Board to provide job training and transition employment for adults and summer employment for at-risk youth.

Agency: Workforce Development

Summary: *Provide a thorough description. Please attach all supporting documentation and talking points.* Increase the allotment of funding for the Milwaukee Area Workforce Investment Board to \$3.5 million. Designate \$2 million for transitional jobs for hard-to-employ adults. The funding will provide approximately 250 jobs.

Triple the current budget for the At-Risk Summer Youth Employment Initiative from \$495,000 to \$1.5 million to provide summer employment for 1,250 at-risk youth. There were over 6,000 applicants for the 415 summer jobs the current appropriation will fund.

Fiscal Impact: \$3,005,000

Funding Source (if applicable): Increase the top income tax bracket by an additional .020% for singles earning over \$250,000 or couples earning over \$300,000.
