I was told you were the clearinghouse for budget amendment requests at LRB. If that is not the case, I apologize, and please contact me and let me know who is.

Senator Grothman would like the following budget amendments drafted.

1. Keep seatbelt enforcement in it's current state, delete provision asking for primary enforcement.
2. Return to the 2007 law requirement that unemployed food stamp recipients attend job training and parents who were behind on child support not receive food stamps.
3. Delete the provision requiring mandated wage levels for public and private construction projects. *(prevail wage) GMM J PJK*
4. Remove all collective bargaining and unionization provisions for home healthcare workers, UW employees, and child care workers. Would prefer this in one amendment, but will understand if it needs to be separate ones. *CMH*
