

TO 2009 ASSEMBLY BILL 75**

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 169, line 9: increase the dollar amount for fiscal year 2009-10 by
3 \$2,056,900 and increase the dollar amount for fiscal year 2010-11 by \$2,056,900 to
4 increase funding for the purpose of making the program payment rate under section
5 49.688 (1) (e) of the statutes, as affected by this act, equal to the rate of payment
6 under section 49.46 (2) (b) 6.h. of the statutes plus 5 percent of that rate of payment
7 and minus 50 cents.

8 **2.** Page 632, line 21: delete lines 21 to 25.
