

1. At the locations indicated, amend the assembly substitute amendment as follows:
2. Page 7, line 9 Does not include establishments that from its inception offered a ethnic cuisine menu, ethnic dance, ethnic music and water pipes with flavored tobacco as a cultural experience business model so long as the following condition are met:
 - (a) was licensed on or before May 13, 2009,
 - (b) will maintain a separate area for the use of the water pipe only,
 - (c) has a separate ventilation system from that of the non-smoking area.

SENATE AMENDMENT,

TO SENATE SUBSTITUTE AMENDMENT 1,

TO 2009 SENATE BILL 181

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 14, line 5: after that line insert:

3 **"SECTION 66m.** 101.123 (3) (n) of the statutes is created to read:

4 101.123 (3) (n) An establishment that, beginning ^{(S)E} ~~on~~ ^{or before} ~~after~~ May 13, 2009 has
5 continuously offered to customers of the establishment ethnic cuisine, dance, music,
6 and the use of water pipes with flavored tobacco as a cultural experience if all of the
7 following apply:

8 1. The establishment operates under a permit issued as required under s.
9 254.64 (1).

10 2. The establishment maintains a separate area for customers using the water
11 pipes.
