1. Page 15, line 12: after that line insert:

"SECTION 76c. 125.34 (4) (am) of the statutes is created to read:

125.34 (4) (am) Any person who holds a Class "B" license if the licensee or his or her agent is in violation of s. 101.123 (2m) (a) to (d).

SECTION 76g. 125.54 (9) of the statutes is created to read:

125.54 (9) CERTAIN SALES PROHIBITED. No wholesaler may sell any intoxicating liquor to a person who holds a "Class B" license if the licensee or his or her agent is in violation of s. 101.123 (2m) (a) to (d).".
