



5 **2.** Page 14, line 21: delete "period; however, no" and substitute "period. The
6 state treasurer shall immediately credit that candidate's account with a line of credit
7 for the amount certified. No".

8 **3.** Page 14, line 21: delete "check" and substitute "line of credit".

9 **4.** Page 14, line 23: delete the material beginning with "distribute" and ending
10 with "for" on line 24 and substitute "certify to the state treasurer the name of each
11 eligible candidate at the spring election together with".
