Jimmy,

AB 273 has been enacted by the legislature and has a error in s. 45.40 (1g) (b). The bill is suppose to add podiatrists to those who can complete medical forms, but the language in paragraph (b), which defines illness, requires a *health care provider* to be acting within the scope of the *podiatrist's* license. This was an error created when an amendment from an earlier session's bill was changed and added. It should require a health care provider to be acting within the scope or the health care provider's license or certification. This was not an error created by your agency.

The revisor says it is not the kind of error that can be fixed by a corrections bill. Instead, it has to be fixed by a law revision bill or a regular bill. In either case, your agency would have to request the law revision committee in the joint legislative council to have a bill prepared or ask me to draft a bill.
