RE: Amendment to Assembly Bill 57

Rep. Pasch has requested for Assembly Bill 57 to be amended as follows:

253.16 Right to breast-feed.

A mother may breast-feed her child in any public or private location where the mother or child is otherwise authorized to be. In those locations, **no person may interfere with the right of a mother to breast-feed her child** may prohibit a mother from breast-feeding her child, ask or direct the mother to move to a different location to breast-feed her child, ask or direct the woman to cover the child or breast while breastfeeding, or otherwise restrict a mother from breast-feeding her child **as provided in this section.**

- 1 At the locations indicated, amend the bill as follows:
- 2 √1. Page 1, line 2: delete "is" and substitute "and her child are".
- 3 √2. Page 1, line 6: delete the material beginning with "is" and ending with
- 4 "breast-feed" on page 2, line 1 and substitute "and child are otherwise authorized
- 5 to be. In such a location, no person may prohibit a mother from breast-feeding her
- 6 child, request or direct a mother to move to a different location to breast-feed her
- 7 child, request or direct a mother to cover her child or breast while breast-feeding, or
- 8 otherwise restrict a mother from breast-feeding".
